

Q1 The Fidelity Group has requested approval of a Special Use Permit for a 9,638 square foot Secretary of State facility at 951 South Rand Road in Deerpath Commons, adjacent to the House of Hope. It is estimated the highest traffic volumes would occur in the morning hours of Tuesday and Saturday. This proposed facility includes four to six vehicle testing sites and a motorcycle testing area behind the Flooring Boutique at 923 South Rand Road. There are no plans to include commercial driver's license (CDL) testing. What feedback would you like to provide the Village on the proposed Secretary of State facility? (Comments will be shared with the Village Board, Planning & Zoning Commission, and posted on the Lake Zurich Transparency Portal).
