**PENDING BUSINESS:**

**Fire:**

Chief Wheelock discussed the hiring status of the new firefighter/paramedic and said at this time he would be waiting until after May 1 to hire Justin Brooks. The position is in the 2013 Village Budget at this time and as long as the position is not eliminated then Justin Brooks would be hired after May 1.

Chief Wheelock confirmed that the disciplinary appeal hearing for Lt. Steve Garris is scheduled for 1 p.m. on April 10 at the Village Hall. All parties have been notified of the hearing.

**Police:**

Suspension hearing status – Commissioner Kelly advised this will go under the current Rules & Regulations. Chief Finlon advised that Officer TeRonde's wife passed away so the notice to him was delayed due to him being off for a few days. He has been noticed of the hearing and has acknowledged notice.

Rule changes - Chief Finlon mentioned that police use a waiver for certain portions of the testing process as well as preference points for current Certified Police Officers. Commissioner Kelly suggested we modify the forms included in the appendixes as the Police or Fire Chief sees fit. Chief Finlon added that the April 10<sup>th</sup> hearing will be under the current rules and regulations.


