-**Wayne McCarthy**- Wanted to know about the stop signs.

-**Jerry Hirschel**- Wanted to know what the numbers from the traffic study were showing.

-**Jeanne Kuackay**- Thinks that Coventry Creek just wants a gated community and wanted to know who made the call on the signs going up.

-**David Rafalowicz**- Voiced concerns about the veracity of the traffic studies and reports.
