**C. Approval to Waive the Formal Bid Process and Approve an Agreement to Purchase Two Flygt Replacement Pumps from Xylem Water Solutions USA for the Quentin and Northwest Pumping Stations in the Amount Not-to-Exceed \$128,677.64**

**Summary:** The 2021 budget includes \$139,500 in the Water and Sewer Fund for two replacement pumps at two village deep-well sites. These pumps will serve as spares in the event they are needed. Xylem Water Solutions USA is a sole source vendor for Flygt products.

**E. Agreement between the County of Lake and the Village of Lake Zurich for Noise Wall Guidelines and Restrictions along Quentin Road between Illinois Route 22 and White Pine Road**

**Summary:** Lake County and Lake Zurich propose to undertake an agreement that will establish guidelines for private property fence extensions by abutting property owners of the area between the property line and noise walls that were constructed as part of the Lake County Division of Transportation Quentin Road reconstruction project. This infrastructure investment project included street widening, stormwater drainage improvements, construction of a multi-use pathway, sidewalk installation, landscaping, the replacement of permanent traffic control signals, and a series of noise walls over which the County has maintenance and jurisdictional authority.

**F. Agreement with Peter Baker and Son Company for Asphalt Materials in an Amount Not-to-Exceed \$30,000**

**Summary:** The 2021 budget includes \$30,000 in the Non-Home Rule Sales Tax Fund for asphalt materials for internal patching repairs by the Public Works Department. A competitive bid opening on March 24, 2021 resulted in three bids received, with Peter Baker and Son Company offering the lowest responsible bid.

**G. Agreement with Patriot Pavement Maintenance for Seal Coating Program in an Amount Not-to-Exceed \$38,876**

**Summary:** The 2021 budget includes \$35,000 for pavement maintenance of 18 locations consisting of municipal parking lots and walking paths. A competitive bid opening on February 19, 2021 resulted in seven bids received, with Patriot Pavement Maintenance offering the lowest responsible bid.

Bids came in higher than expected, resulting in a Staff recommendation to defer the engineering and repaving of the Alpine Path currently in the 2021 budget at \$5,250 to offset the \$3,876 shortfall for sealcoating this year.

Eric Dubiel, 25 N. Pleasant Rd., addressed the Board on vacant properties, public and privately owned; requested a moratorium on late fees on water bills.

There will be a Styrofoam recycling programme starting in mid-April in cooperation with the Village and American Legion, where the container will be placed.

  - C. Ordinance Approving a Special Use Permit for Sungor Transportation at 410 Telser Road ORD. # 2021-03-405  
**Summary:** Sungor Transportation has filed a zoning application for the property at 410 Telser Road seeking a Special Use Permit to establish a yard and maintenance facility associated with a trucking and courier services company. The company proposes to establish a trucking company, office and maintenance area in the existing industrial building, along with a truck parking yard on the vacant parcels to the north. Sungor Transportation plans to operate a fleet of 35 semi-trucks at this location with eight full-time employees. The Planning and Zoning Commission held a public hearing on February 17, 2021 to consider this application and voted 7-0 in favor of recommending approval.

- D. Ordinance Amending Title 3 of Chapter 3 of the Village of Lake Zurich Municipal Code to Decrease Authorized Class A Liquor License for Green Garden at 1241 South Rand Road and Decrease Class M Liquor License for Sake Sushi & Grill at 884 South Rand Road ORD. # 2021-03-406**

**Summary:** The extended 2020 / 2021 liquor license renewal period concluded on February 28, 2021, with two local establishments amending their license. Green Garden / Chef Bo cancelled its Class A liquor license as the business has transitioned to mostly takeout and Sake Sushi & Grill renewed their Class A liquor license but not their Class M license, which allowed them to offer BYOB.

- E. Agreement Among the Village of Lake Zurich and Village of Kildeer regarding Use of Lake Zurich Gas Pumps and Fuel**

**Summary:** The existing fuel agreement between Lake Zurich and Kildeer expires on April 30, 2021. The proposed renewal agreement allows Kildeer to continue refueling its fleet at the Lake Zurich Community Services Facility for another two years at a rate of 15% of the dollar amount of fuel consumed, in addition to the cost of the fuel itself.

- F. Agreement between the Village of Lake Zurich and the Village of Kildeer for Vehicle Servicing**

**Summary:** The existing fleet services agreement between Lake Zurich and Kildeer expires on April 30, 2021. The proposed renewal agreement allows Kildeer to continue utilizing Lake Zurich's fleet maintenance services at a rate of \$94 per hour, in addition to the cost of any parts and supplies used in the course of the repairs.

**7. NEW BUSINESS**

- A. Agreement with Builders Paving LLC of Hillside, Illinois for the 2021 Road Resurfacing Program in the Amount Not To Exceed \$1,798,060 (Trustee Spacone)**

**Summary:** The 2021 budget includes \$1,825,000 in the Non-Home Rule Sales Tax Fund for the annual road resurfacing program. The program consists of pavement resurfacing, concrete repair, utility infrastructure repair, and other related items.

Upon completion of the proposed improvements, the roads should have an estimated service life of 15-20 years with proper maintenance. Roads slated for improvements in 2021 include the Quail Run subdivision and Deerpath Road, with construction expected to begin in mid-April.

Eight competitive bids were received on February 24, 2021, with the lowest responsible bid submitted by Builders Paving LLC for the base amount of \$1,594,360. The requested amount for the Board to authorize includes contingency and engineering costs.

Public Works Dir. Mike Brown addressed the Board about the timeline and answered their questions. By bidding early, a favourable price was received.

**Recommended Action:** A motion was made by Trustee Spacone, seconded by Trustee Euker, to approve an agreement with Builders Paving LLC of Hillside, Illinois for the 2021 Road Resurfacing Program in the Amount Not-To-Exceed \$1,798,060.

**B. Courtesy Review for Redevelopment Proposal of Village-Owned Properties at 7, 15, and 19 South Old Rand Road**

**Summary:** Ms. Lovejoy, the owner of Lake Zurich Florist, is proposing the redevelopment of the vacant property at 7, 15, and 19 South Old Rand Road, which has been owned by the Village since 2006. The existing parcels comprise a land area of 0.45 acres within the B-2 Central Business District and are subject to the DR – Downtown Redevelopment Overlay District.

The Lovejoy's propose to acquire the property from the Village and redevelop them with a two-story mixed-used building containing three commercial tenant spaces on the first floor and three residential units on the 2<sup>nd</sup> floor. The commercial tenant spaces would be designed with larger commercial storefront windows with direct access to the front and rear of the building. 27 parking spaces are proposed to be located at the rear of the building and accessible from Old Rand Road.

It is the intent of Ms. Lovejoy to relocate her existing florist business on Main Street within one of the new commercial tenant spaces and rent the remaining spaces to retail businesses with clientele that would allow the businesses to complement each other.

The Developer intends to propose the redevelopment of the property as a Public-Private Partnership, the details for which are currently being prepared.

Dir. Of Community Development Sarosh Saher introduced Amping Lovejoy, owner of LZ Florist, and Matt Lovejoy, and Ms. Lovejoy addressed the Board on the proposal. The Board responded with their comments, including the architectural style; mixed use of retail and residential; timeline; parking; price point for apartments and possible destination shopping. Staff answered the Board's questions about public/private partnership, infrastructure and PZC application. Mayor Poynton thanked Mr. and Mrs. Lovejoy for their proposal and reminded all that this is a courtesy review.

**Recommended Action:** This is a non-voting item at this time. The developer and Village Staff seek to understand the Board's preferences towards the redevelopment proposal.

**8. TRUSTEE REPORTS**

Trustee Spacone reported on the Styrofoam recycling programme and gave credit to Kyle Kordell, Asst. to the Village Manager, who researched the recycling idea that Mr. Spacone mentioned at a Board meeting in January.

Trustee Euker thanked Bonnie Caputo and Elke Kadzielawski for the cleanliness of the Chalet in Paulus Park which Ms. Euker used for her theatre group.

**Subject:** Pump Replacement at Quentin & Northwest Pumping Stations

**Issue:** The original pumps for the Quentin and Northwest Sanitary Sewer Pumping Stations have reached the end of their useful life. To ensure pump station reliability, the pumps require replacement. In 2018 we began a program to replace one pump at each location per year, over a five (5) year period.

**Village Strategic Plan:** This agenda item is consistent with the following Goals and Objectives of the Strategic Plan.

- Goal #3 – *Infrastructure: Develop a formalized, long-range sanitary sewer system improvement plan.*

**Background:** The Quentin and Northwest Pumping Stations, constructed in 1993, utilize four pumps in normal operation and provide additional capacity during elevated flow conditions. The existing pumps are obsolete, worn and deteriorated. Repairing these pumps is no longer cost effective due to the high cost of the repairs and the limited service life obtained with each repair. Each pumping station also has one dedicated spare pump to replace a failed unit. At both Pumping Stations, the spare pumps have replaced failed units leaving us without a spare for either location.

**Analysis:** Flygt (pronounced flight) pumps and control systems are original for the Quentin and Northwest Sanitary Sewer Pumping Stations and are integral to each other (pumps vs controls) requiring replacements to be Flygt brand. Xylem Water Solutions USA, Inc. Flygt Products (Sole source vendor) has provided us a proposal for \$128,677.64 to provide one replacement pump with sensor modules for each pump station. The FY 2021 Budget includes \$139,500 for purchasing one replacement pump for each pump station. Pump replacements for Quentin and Northwest Pumping Stations have been planned for in the Village's 20-year Community Investment Plan.

**Recommendation:** Acceptance of proposal from Xylem Water Solutions USA, Inc. Flygt Products for purchasing one Flygt replacement pump each for the Quentin and Northwest Pumping Stations in an amount not to exceed \$128,677.64.



**WHEREAS**, pursuant to 65 ILCS 5/11-76.4 and in the opinion of a simple majority of the corporate authorities holding office in the Village of Lake Zurich Lake County, Illinois, ("Village") it is no longer necessary, useful, or for the best interests of the Village to retain ownership of the personal property hereinafter described; and

**WHEREAS**, it has been determined by the President and the Board of Trustees of the Village of Lake Zurich to dispose of said personal property in the manner described in this Ordinance.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Lake Zurich, Lake County and the State of Illinois, as follows:

**Section 1. Recitals.** The foregoing recitals are hereby incorporated into this Ordinance as findings of the President and Board of Trustees.

**Section 2. Disposal of Surplus Property.** The President and Board of Trustees find that the personal property described as follows in **Exhibit A** by this reference incorporated into this Ordinance (the "Property") is no longer necessary or useful to the Village, and thus the Village Manager for the Village of Lake Zurich is hereby authorized to direct the sale or disposal of the property in the manner most appropriate to the Village consistent with 65 ILCS 5/11-76.4. The property shall be sold "as is."

**Section 3. Effective Date.** This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.

Re: **Agreement between Lake County and Lake Zurich for  
Noise Wall Guidelines and Restrictions along Quentin Road**

**Issue:** Lake County and Lake Zurich propose to undertake an agreement that will establish guidelines for private property fence extensions and use by abutting property owners of the area between the property line and noise walls (approximately 5-feet) that were constructed as part of the Quentin Road reconstruction project. The agreement is being coordinated with the Lake County Division of Transportation.

**Village Strategic Plan.** This agenda item is consistent with the following objectives under Goal #2 – Development:

- Become more Business Friendly and Customer Oriented

**Background:** Lake County is nearing completion of improvements to Quentin Road between Illinois Route 22 and White Pine Road, which include road reconstruction and widening, drainage improvements, construction of a multi-use pathway, sidewalk, landscaping, and the replacement of permanent traffic control signals.

As part of the project, the County constructed a series of noise walls within the public right-of-way over which the County has maintenance and jurisdictional authority. The noise walls are constructed approximately 4 to 5 feet away from the rear lot lines of the adjacent homes thereby leaving a gap between their rear yards and the wall. The agreement will allow affected residents, if they so choose, to extend their fences into the right-of-way and up to the noise wall.

**Analysis:** The residences affected by the noise walls are those within Bristol Trail, Hunter's Creek and Chestnut Corners subdivisions that back up to the Quentin Road right-of-way.

The agreement provides for the procedures, roles and responsibilities of Lake Zurich to issue permits to allow residents to extend their fences if they so choose to completely enclose their rear yards and to maintain the area in between their rear yards and the wall. The County will retain all remaining permitting rights and also be responsible for the maintenance of the walls.

Items within the agreement that are of note include:

- a. Residents may construct a fence within the County right-of-way up to, but not connected to or attached in any manner or form to the noise wall. A permit for the fence or fence extension shall first be obtained from the Lake Zurich Building Department prior to construction.
- b. The only feature allowed for construction within the right-of-way will be fence extensions.
- c. Residents will be required to maintain the area between the right-of-way line (their rear property line) and the noise wall without any reimbursement by the County. Maintenance includes weed cutting and otherwise maintaining the lawn (turf grass) in that area.
- d. Access will need to be granted by the owners to the County, Village, utility companies or other agencies that will need to access the right-of-way when needed.
- e. If removal and installation of a fence is required by such agencies or utility companies, such costs to restore the fence will be the responsibility of the property owner.
- f. If removal is required, residents are advised to make arrangement for the security of their pets, children, property, etc.

**Recommendation:** The County and Village Staff agree with the terms and conditions of the proposed agreement and recommend its approval. If approved, Lake Zurich agrees to provide written notice to the affected property owners informing them of the guidelines and restrictions of the agreement. Lake County has likewise agreed to record the agreement with each property's record at the Lake County Recorder.

**AGREEMENT  
BETWEEN THE COUNTY OF LAKE  
AND THE VILLAGE OF LAKE ZURICH  
FOR NOISE WALL GUIDELINES AND RESTRICTIONS ALONG

BETWEEN ILLINOIS ROUTE 22 AND WHITE PINE ROAD,**

**THIS AGREEMENT** is entered into this \_\_\_\_ day of April, A.D. 2021 , by and between the COUNTY OF LAKE, Illinois, an Illinois body politic and corporate, acting by and through its Chair and County Board, hereinafter referred to as the COUNTY, and the Village of Lake Zurich, an Illinois Municipal Corporation, acting by and through its Mayor and Board of Trustees, hereinafter referred to as the VILLAGE. The COUNTY and the VILLAGE are hereinafter referred to collectively as “parties” to THIS AGREEMENT, and either one is referred to individually as a “party” to THIS AGREEMENT.

**WITNESSETH**

**WHEREAS**, the COUNTY and the VILLAGE have previously entered into the AGREEMENT BETWEEN THE COUNTY OF LAKE AND THE VILLAGE OF LAKE ZURICH FOR ROADWAY IMPROVEMENTS ALONG QUENTIN ROAD (COUNTY HIGHWAY 5) BETWEEN ILLINOIS ROUTE 22 AND WHITE PINE ROAD, INCLUDING WATERMAIN, SIDEWALK, HARDSCAPE AND LANDSCAPING IMPROVEMENTS AND TREE MAINTENANCE dated the fifth day of March, A.D. 2018, (hereinafter referred to as the IMPROVEMENT AGREEMENT); and,

**WHEREAS**, the IMPROVEMENT AGREEMENT defines the IMPROVEMENT as certain permanent roadway and non-motorized facility improvements along Quentin Road (COUNTY Highway 5) from Illinois Route 22 to White Pine Road, including road reconstruction and widening, drainage improvements, construction of multi-use path, sidewalk, landscaping, and the replacement of permanent traffic control signals; and,

**WHEREAS**, the construction contract for the IMPROVEMENT has been awarded and construction work of the IMPROVEMENT is nearing completion; and

**WHEREAS**, the IMPROVEMENT included construction of noise walls within the public right-of-way for which the COUNTY has maintenance and jurisdictional authority and which is designated for use of roadway purposes; and,

**WHEREAS**, the COUNTY and the VILLAGE are desirous to establish guidelines and restrictions for fence extensions and use of the area between the right-of-way (property line) and

Noise Wall (approximately 5-feet) that will remain public right-of-way for use of roadway purposes under the jurisdiction of the COUNTY and,

**WHEREAS**, the COUNTY is desirous to retain permitting authority for the COUNTY right-of-way except as described in THIS AGREEMENT; inclusive of any utility line installation, operation or maintenance within the COUNTY right-of-way; and,

**WHEREAS**, the COUNTY is desirous that the VILLAGE issue permits to property owners that wish to extend their side yard fence up to the Noise Wall in accordance with the guidelines and restrictions set forth in THIS AGREEMENT; and,

**NOW, THEREFORE**, for and in consideration of the mutual covenants contained herein, made pursuant to all applicable statutes, local ordinances and authority, the COUNTY and the VILLAGE do hereby enter into the following:

#### **SECTION I.**

##### **Recitals/Headings**

1. It is mutually agreed by and between the parties hereto that the foregoing preambles are hereby incorporated herein as though fully set forth.
2. It is mutually agreed by and between the parties hereto that the "headings" as contained in THIS AGREEMENT are for reference only and the actual written provisions, paragraphs and words of THIS AGREEMENT shall control.

#### **SECTION II.**

##### **Quentin Road Noise Wall Jurisdiction**

1. It is mutually agreed by and between the parties hereto that the Noise Wall constructed as a part of the IMPROVEMENT is owned and maintained by the COUNTY.
2. It is mutually agreed by and between the parties hereto that the Noise Wall is located on public right-of-way which is designated for use of roadway purposes.

It is further mutually agreed by and between the parties hereto that the COUNTY has jurisdiction of the public right-of-way and Quentin Road (County Highway 5).

3. It is mutually agreed by and between the parties hereto that the COUNTY retains permitting authority for the COUNTY right-of-way except as described in THIS AGREEMENT.

4. The COUNTY agrees to allow property owners to extend their side yard fence up to, but not connect to, the Noise Wall provided a permit is obtained from the VILLAGE.
5. The VILLAGE agrees that permits issued to property owners shall include the guidelines and restrictions set forth in Section III of THIS AGREEMENT.

**SECTION III.**  
**Guidelines and Restrictions for Fence Extensions and**  
**Use of Property Adjacent to the Noise Wall**

1. The VILLAGE agrees that permits issued shall stipulate that the area between the right-of-way line (property line) and Noise Wall (approximately 5-feet) will remain public right-of-way for use of roadway purposes under the jurisdiction of the COUNTY.

The VILLAGE further agrees to provide written notice to the property owners/tenants informing them of the guidelines and restrictions as described in THIS AGREEMENT.

2. The COUNTY agrees to record THIS AGREEMENT with each individual property adjacent to the Noise Wall constructed as part of the IMPROVEMENT.
3. It is mutually agreed by and between the parties hereto that if a permit is not secured, the Village may invoke any penalties that are set forth in their ordinances.

It is further mutually agreed by and between the parties hereto that in the absence of a permit, any fencing encountered shall be treated as an encroachment on the COUNTY right-of-way enforceable by the COUNTY.

4. It is mutually agreed by and between the parties hereto that the COUNTY from time to time, may need to work on said Noise Wall, which may include removal of the Noise Wall panels.

It is further mutually agreed by and between the parties hereto that the COUNTY will make a good faith effort to notify any property owner/tenant prior to said work.

5. Use of COUNTY right-of-way adjacent to the Noise Wall shall include the following restrictions for the adjacent residential property owners or tenants of the adjacent residential property (hereinafter referred to as "Residents"):
- a. Residents may construct a fence within the COUNTY right-of-way up to, but not connected to or attached in any manner or form to the Noise Wall. A permit for such fence shall first be secured by the Lake Zurich Building Department prior to construction of such fence.

- b. No improvement other than a fence as approved under Section 5.a of this agreement shall be authorized for construction within the COUNTY right-of-way. Improvements including but not limited to sheds, playhouses, swing sets, trampolines, raised planter beds, trees, bushes/shrubs, or storage of firewood that exceeds one (1) full cord (4 feet wide, 4 feet high, and 8 feet long) shall NOT be authorized or permitted for construction or installation within the COUNTY right-of-way.
  - c. Residents shall be required to maintain the area between the right-of-way line (property line) and the Noise Wall without reimbursement by the COUNTY for their cost of maintaining such area. Maintenance shall involve weed cutting and otherwise maintaining the lawn (turf grass) in conformance with Section 4-4-2 of the Lake Zurich Municipal Code.
  - d. It may be necessary for the COUNTY and other agencies that may be using the COUNTY right-of-way via permit, such as the VILLAGE and Utility Companies, to access the right-of-way from time to time. The property owner/tenant is required to allow access to the COUNTY right-of-way via the property owner/tenant's property.
  - e. All cost associated with the removal and installation of a fence shall be the responsibility of the property owner, inclusive of any fence removal and installation costs incurred by the COUNTY necessary to access and maintain the Noise Wall and any utility company line operation, maintenance or installation within the COUNTY right-of-way.
  - f. It shall be the property owner's/tenant's responsibility to make provisions for access by the COUNTY, VILLAGE and Utility Companies in case a panel needs to be removed or work carried out within the COUNTY right-of-way. In such instances, security for pets, children, property, etc. will be the obligation of the property owner/tenant to arrange at no cost to the COUNTY.
6. The VILLAGE agrees to keep records of issued permits and, at the time of a permit issuance, to send a copy to the Lake County Division of Transportation's Permit Department for their files.

#### **SECTION IV. General Provisions**

- 1. It is mutually agreed by and between the parties hereto that nothing contained in THIS AGREEMENT is intended or shall be construed as, in any manner or form, creating or establishing a relationship of co-partners between the parties hereto, or as constituting the VILLAGE (including its elected officials, duly appointed officials, employees and agents), the agent, representative or employee of the COUNTY for any purpose or in any manner,



whatsoever. The VILLAGE is to be and shall remain independent of the COUNTY with respect to all services performed under THIS AGREEMENT.

2. It is mutually agreed by and between the parties hereto that THIS AGREEMENT shall not be construed, in any manner or form, to limit the power or authority of the COUNTY or the COUNTY's County Engineer to maintain, operate, improve, construct, reconstruct, repair, manage, widen or expand COUNTY Highways as may be best determined, as provided by law.
3. It is mutually agreed by and between the parties hereto that each party warrants and represents to the other party and agrees that: (1) THIS AGREEMENT is executed by duly authorized agents or officers of such party and that all such agents and officers have executed the same in accordance with the lawful authority vested in them, pursuant to all applicable and substantive requirements; (2) THIS AGREEMENT is binding and valid and will be specifically enforceable against each party; and (3) THIS AGREEMENT does not violate any presently existing provision of law nor any applicable order, writ, injunction or decree of any court or government department, commission, board, bureau, agency or instrumentality applicable to such party.
4. It is mutually agreed by and between the parties hereto that THIS AGREEMENT shall be deemed to take effect on the date that the last authorized agent of the parties hereto affixes his/her signature to THIS AGREEMENT.
5. It is mutually agreed by and between the parties hereto that THIS AGREEMENT shall be enforceable in any court of competent jurisdiction by each of the parties hereto by any appropriate action at law or in equity, including any action to secure the performance of the representations, promises, covenants, agreements and obligations contained herein.
6. It is mutually agreed by and between the parties hereto that the provisions of THIS AGREEMENT are severable. If any provision, paragraph, section, subdivision, clause, phrase or word of THIS AGREEMENT is for any reason held to be contrary to law, or contrary to any rule or regulation having the force and effect of law, such decision shall not affect the remaining portions of THIS AGREEMENT.
7. It is mutually agreed by and between the parties hereto that the agreement of the parties hereto is contained herein, and that THIS AGREEMENT supersedes all oral agreements and negotiations between the parties hereto relating to the subject matter hereof.

8. It is mutually agreed by and between the parties hereto that any alterations, amendments, deletions or waivers of any provision of THIS AGREEMENT shall be valid only when expressed in writing and duly executed by the parties hereto.
9. THIS AGREEMENT shall be binding upon and inure to the benefit of the parties hereto, their successors and assigns. No party hereto may assign, transfer, sell, grant, convey, deed, cede or otherwise give over, in any manner or form, any of its duties, obligations and/or responsibilities as heretofore set forth in THIS AGREEMENT without first obtaining the expressed written consent and permission of the COUNTY, except as provided for in THIS AGREEMENT.
10. THIS AGREEMENT may be executed in multiple identical counterparts, and all said counterparts shall, individually and taken together, constitute THIS AGREEMENT.
11. It is mutually agreed by and between the parties hereto that any notice required by the provisions of THIS AGREEMENT shall be mailed to:

Award Recommendation**

**Issue:** The FY 2021 budget includes \$30,000 in the Non-Home Rule Sales Tax Fund for asphalt materials for internal patching repairs by the Public Works Department.

**Background:** The Village is committed to maintaining safe, drivable roadways. The asphalt materials contract provides Public Works the means to pick up asphalt, as needed, from a local asphalt plant for in-house repairs from infrastructure repairs, and roadway patching.

**Village Strategic Plan:** This agenda item is consistent with the following Goals and Objectives of the Strategic Plan.

- **Goal #3 – Infrastructure:** *Develop and formalize a long-range street maintenance program.*
- **Goal #4 – Service Sustainability:** *Identify Methods of Alternate Service Delivery.*

**Analysis:** Public Works enters into an annual contract for asphalt materials. Asphalt is purchased at a unit price per ton. Staff prepared the bidding specifications and administered the bid opening held on March 24, 2021.

**The Village received three (3) bids. The bid results are shown below:**

Name of Bidder	Unit Price/Ton
Peter Baker & Son Co (Lake Bluff, IL)	\$49.00
Arrow Road Construction Company (Elk Grove Village, IL)	\$52.00
Builders Asphalt (Hillside, IL)	\$54.00

The lowest responsible bid was received from Peter Baker & Son Co of Lake Bluff, Illinois.

The Peter Baker & Son Co asphalt plant is located in Lakemoor, Illinois, approximately 11 miles from Lake Zurich. Peter Baker & Son Co was awarded the asphalt materials contract last year. Staff was satisfied with the quality of product and level of service provided.

**Recommendation:** Award a contract for the 2021 Asphalt Materials purchase to Peter Baker & Son Co of Lake Bluff, IL in an amount not-to-exceed \$30,000.00.

## MEMORANDUM

**Date:** March 29, 2021  
**To:** Ray Keller, Village Manager *PK*  
**From:** Michael J. Brown, Public Works Director  
**Subject:** 2021 Seal Coating and Striping Award Recommendation

**Issue:** The FY 2021 budget includes \$35,000.00 for pavement maintenance of Village owned parking facilities and pathways.

**Background:** In order for the Village to achieve the maximum life on its parking lots and walking paths, a pavement maintenance program consisting of patching, seal coating and crack filling is necessary to preserve the structural integrity of the Villages assets. Sites are inspected on an annual basis and recommended for maintenance on a three-year rotation.

**Village Strategic Plan:** This agenda item is consistent with the following Goals and Objectives of the Strategic Plan.

- Goal #3 – Infrastructure: *Prepare a Formalized Municipal Property Maintenance program.*
- Goal #3 – Infrastructure: *Identify and Resolve Outstanding Concerns with Village Owned Property.*

**Analysis:** This year's program includes 18 locations consisting of municipal parking facilities and walking paths throughout the Village. Staff solicited bids for the 2021 Crack Sealing Program on January 29, 2021. The bid opening occurred on February 19, 2021. The Village received seven (7) bids. The bid results are shown on Page 2. A full reference list was made available to Village staff for review. The results of the reference inquiries were found to be favorable. Staff has also confirmed with Patriot Pavement Maintenance that all operations, installation practices, and documentation shall comply with the specifications set forth in the bid documentation.

Estimates formulated during budget preparations for this program were lower than the bids received. The maintenance schedule for this program has been created to ensure the longevity of the surface while remaining fiscally responsible. Deviation from the schedule poses higher priced needs in the future. Staff intends to defer the engineering and repaving of the Alpine Path currently budgeted at \$5,250.00 in order to offset the \$3,875.09 shortfall and complete this year's program in its entirety.

**Recommendation:** Award a contract for the 2021 Seal Coating program to Patriot Pavement Maintenance of DesPlaines, IL for a total not to exceed \$38,876.00.





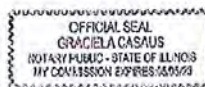

Subject: Intergovernmental Agreement with the Village of Island Lake for Dispatch Services

---

**Issue:** The Village of Lake Zurich has provided public safety radio dispatch services to the Village of Island Lake since 2013. The current three-year agreement expires on April 30, 2021 and needs to be updated.

**Analysis:** The parties to the original agreement desire to continue the provision of services as revised by the intergovernmental agreement attached to the Resolution as Exhibit A (the “Revised Agreement”). The Village of Island Lake approved the agreement on March 25, 2021.

**Village Strategic Plan:** This agenda item is consistent with the following Goals and Objectives of the Strategic Plan.

- Goal # 1 – Financial Sustainability - *Identify opportunities to provide services to other agencies.*

**Recommendation:** Accept the Resolution approving a dispatch services agreement among the Village of Lake Zurich and the Village of Island Lake.

***Dispatch Services Agreement Between the Village of Lake Zurich  
and the Village of Island Lake***

This Agreement is made and entered into as of this \_\_\_\_\_ day of April 2021, by and between the Village of Lake Zurich, Lake County, Illinois an Illinois municipal corporation (“Lake Zurich”), and the Village of Island Lake, Lake County, Illinois, McHenry County, Illinois, an Illinois municipal corporation (“Island Lake”) (Lake Zurich and Island Lake shall be referred to collectively as the “Parties”),

**WITNESSTH**

WHEREAS, Lake Zurich and Island Lake desire to enter into an agreement on or about May 1, 2021, under which Lake Zurich agrees to provide Island Lake with certain public safety radio dispatch services utilizing personnel and equipment maintained and operated by Lake Zurich; and

WHEREAS, Island Lake ( the “Recipient”) desires to enter into this Agreement with Lake Zurich to continue the mutually beneficial arrangement regarding public safety radio dispatch services provided by Lake Zurich; and

WHEREAS, the Parties have the power and authority to enter into this Agreement pursuant to the provisions of Article VII, section 10 of the Illinois Constitution of 1970, and the Illinois Intergovernmental Cooperation Act, as amended, 5 ILCS 220/1 et. Seq., and other applicable authority;

NOW, THEREFORE, for and in consideration of the mutual covenants herein made and pursuant to all applicable statutes and local ordinances, and for other good and valuable consideration the receipt and sufficiency of which are hereby mutually acknowledged, the Parties do hereby agree as follows:

**Section 1. Recitals.**

The foregoing recitals are by this reference incorporated herein and made a part hereof.

**Section 2. Dispatch Services Provided by Lake Zurich.**

Lake Zurich hereby agrees that its radio dispatchers/telecommunicators shall accept and monitor the emergency telephone numbers of Island Lake in order to obtain information to assign calls-for-service and monitor traffic on police and fire radio frequencies, maintain a log of all such communications (electronic or written), relay information received by such means to Island Lake's on-duty police personnel by means of voice radio and mobile data communications, monitor communications from and between Island Lake's police personnel and relay messages as necessary, and accurately input and update call-for-service information into the computer aided dispatch (CAD) system.

Lake Zurich shall provide dispatch services continuously, 24 hours a day, seven days a week, including all State of Illinois and Federal holidays; provided, however, that dispatch services shall be provided to Island Lake only to the extent possible utilizing Lake Zurich's dispatch personnel and equipment. In the event of immediate, overlapping needs for dispatch services, the calls, when possible, shall have priority in accordance with the seriousness of the service requested. The term "priority" shall have the meaning determined therefore by the Joint Operations Committee and the Lake County ETSB, as the Joint Operations Committee is defined in Section 8 of this Agreement, and approved by the Lake Zurich Board of Trustees.

**Section 3. Dispatch Services Disruption or Failure; Waiver.**

If dispatch services are disrupted or fail for any reason, due to an event, condition or circumstance beyond the reasonable control of Lake Zurich, Lake Zurich shall notify Island Lake of such disruption as soon as practicable and shall inform Island Lake of the nature of the disruption or failure, if known, as well as the expected length of time before dispatch services are restored. Lake Zurich also shall notify Island Lake as soon as dispatch services are restored. Island Lake hereby waives and releases any and all claims or causes of action against Lake Zurich for costs, fees, claims, or expenses incurred by Island Lake that arise out of or relate in any way to any such disruption or failure of dispatch services.

**Section 4. Determination and Payment of Costs.**

Pursuant to this Agreement, Island Lake agrees to pay Lake Zurich an annual fee for dispatch services as follows:

May 1, 2021 to April 30, 2022 - \$148,950.36

May 1, 2022 to April 30, 2023 - \$154,908.37

May 1, 2023 to April 30, 2024 - \$161,104.70

The annual fees for years two and three reflect a 4% increase.

A. Time for Payment: Island Lake shall pay to Lake Zurich the dispatch service fee for each year during the term of this Agreement. Island Lake shall pay the monthly installment to Lake Zurich by the 15<sup>th</sup> of each month. There shall be no discount for any lump-sum pre-payment of annual dispatch service fees. Alternative payment options, including quarterly or annual payments may be arranged if mutually acceptable by both Island Lake and Lake Zurich. For purposes of this Agreement, a year will begin May 1<sup>st</sup> and end April 30<sup>th</sup>.

B. Conditional Right to Deny Services: Lake Zurich shall have the right, in the exercise of its sole and absolute discretion based on factors such as system capacity, personnel, costs, payments, location, and similar factors, to deny dispatch services for any extraterritorial area (any area proposed to be added to this agreement that is not currently within the municipal boundaries of the Village of Island Lake) unless such area is reviewed and recommended by Lake Zurich in advance of the commencement of police services or dispatch services to such area.

**Section 5. Effective Date, Term and Termination:**

This Agreement shall commence on May 1, 2021 and shall remain in full force and effect until April 30, 2024. It is understood that the Village is not incurring any additional dispatch expenses by executing this agreement and, for that reason, either party hereto may, without penalty, and for any reason or no reason at all, cancel this Agreement prior to its natural termination on April 30, 2024. At any time during the term of the Agreement, if there are any additional costs being proposed which are based in whole or part on Island



Lake's membership, use or continued use of the system, prior to incurring such costs, Island Lake will be notified and provide its written consent/agreement to the expenditure and assume responsibility for its pro rata share of such costs.

**Section 6. Maintenance of the Radio System.**

The Village of Lake Zurich agrees to maintain the current radio systems as the systems exist at the initiation of this Agreement. Island Lake shall be responsible for procuring, programming, and maintaining their Lake Zurich compatible mobile and portable radio equipment for use by their personnel on this system. However, any upgrade to the Lake Zurich radio system due to Island Lake's expansion of public safety services or Island Lake's provision of public safety services to another unit of local government will be the sole responsibility of Island Lake. All equipment necessitated by any expansion of the public safety services must be compatible with the radio system used by the Lake Zurich 9-1-1 Dispatch Center. Any modification of the radio system used by the Lake Zurich 9-1-1 Dispatch Center required by this expansion will be performed by a radio service provider chosen by Lake Zurich. All costs associated with the expansion of public safety services will be paid by the agency responsible for the expansion.

The base radio stations, dispatch radio stations, antennas, satellite receivers, and other related radio equipment remain the property of Lake Zurich. With obsolescence and changing regulatory requirements Lake Zurich may from time-to-time upgrade the radio infrastructure. Changes will be communicated to all partner agencies well in advance in implementation.

**Section 7. Upgrade of Telephone System.**

Island Lake agrees that any changes in their service area that requires installation of additional, or an upgrade to, existing telephone equipment to the Village of Lake Zurich Public Safety Answering Point, 9-1-1 Dispatch Center shall be the sole expense of Island Lake.

**Section 8. Joint Operations Committee.**

The Joint Operations Committee comprised of a single representative from each Lake Zurich dispatch partner, may convene from time-to-time to discuss issues that mutually affect all partners. A representative from the Village of Lake Zurich shall serve as chairperson of the Joint Operations Committee. Unless prohibited by law from doing so, all dispatch partners agree to operate under a standardized operational procedure as prescribed by Lake Zurich and the Lake County Emergency Systems Telephone Board (ETSB). Procedural issues and day-to-day operations will be addressed by the Lake Zurich Police Department. It is expressly understood that Lake Zurich is responsible for the management of dispatch personnel.

**Section 9. Enforcement.**

The Parties hereto may, in law or in equity, by suit, action, mandamus, or any other proceeding including without limitation specific performance, enforce or compel the performance of this Agreement; provided, however, that each Recipient agrees that it shall not seek, and does not under any circumstances have the right to seek, to recover any judgment for monetary damages against Lake Zurich or any Lake Zurich elected or appointed officials, agents, representatives, attorneys, or employees on account of the negotiation, execution, performance, or breach of any of the terms or conditions of this Agreement, except only against Lake Zurich in the event of a willful and malicious failure and refusal by Lake Zurich to provide dispatch services in accordance with the terms of this Agreement. In the event of a judicial proceeding brought by any of the Parties to this Agreement against another Party for enforcement or for breach of any provision of this Agreement, the prevailing party in such judicial proceeding shall be entitled to reimbursement from the unsuccessful Party of all costs and expenses, including reasonable attorney's fees, incurred in connection with such judicial proceeding.

**Section 10. Indemnity.**

Island Lake shall defend, indemnify and hold harmless Lake Zurich, and its officers, agents and employees, from any and all liability, losses, costs, damage or expense, or injury to person or property, including reasonable attorneys' fees, arising out of the execution of this

Agreement, the performance of any act pursuant to this Agreement, or the termination of this Agreement in accordance with its terms, with the exception of any liability, losses, costs, damage or expense, or injury to person or property arising out of or resulting from either: (1) the sole action, or malfeasance of Lake Zurich, or its officers, agents and employees in the performance or non-performance of any act pursuant to the Agreement; or (2) except as otherwise provided in Section 2 and 3 of this Agreement from Lake Zurich's inability or failure to perform its obligations under this Agreement.

Lake Zurich shall defend, indemnify and hold harmless Island Lake, and its officers, agents and employees, from all and any liability, losses, costs, damage or expense, or injury to person or property, including reasonable attorneys' fees, arising out of or resulting from the sole action, or malfeasance of Lake Zurich or its officers, agents or employees in the performance or non-performance of an act pursuant to this Agreement or except as otherwise provided in Section 2 and 3 of this Agreement Lake Zurich's inability or failure to perform any provisions of this Agreement.

The above indemnities are for the performance or omission of any act pursuant to this Agreement or the termination of this Agreement according to its terms. Any liability of one Party to the other incurred during the term of this Agreement, or any extensions hereof, shall not be extinguished.

#### **Section 11. Appropriations.**

To the extent permitted by applicable law, Lake Zurich agrees to appropriate annually such funds as may be reasonably necessary to provide dispatch services pursuant to this Agreement. Island Lake agrees to appropriate annually all funds necessary to make payments to Lake Zurich pursuant to this Agreement.

#### **Section 12. Amendments; Waivers.**

This Agreement and the rights created by this Agreement may not be amended, modified, or waived in any respect except by written agreement expressly referring to this Agreement and duly validly authorized, executed, and delivered by all of the Parties hereto.

**Section 13. Tort Immunity.**

Nothing in this Agreement shall express or imply any limitation to or waiver of the tort immunities provided to Lake Zurich or Island Lake and their respective employees, as provided by the Local Governmental and Governmental Employees Tort Immunity Act (745 ILCS 10/1, et seq.).

**Section 14. Notices.**

All notices and other communications in connection with this Agreement shall be in writing and shall be deemed delivered to the addressee thereof when delivered in person at the address set forth below or three business days after deposit thereof in any main or branch United States post office, certified or registered mail, return receipt requested, postage prepaid, properly addressed to the Parties, respectively, as follows:

By notice complying with the foregoing requirements of this Section 14, each Party shall have the right to change the address or addressee or both for all future notices and communications to such party, but no notice of such change of address shall be effective until actually received.
