THE DRIP LINE: A Missive for Those Interested in the Urban Forest

A HOLISTIC VIEW OF THE URBAN FOREST:

It is interesting to contemplate the probability of an earth environment either on or in the lithosphere, on or in the hydrosphere, or in the atmosphere not being influenced by our species' presence. The probability is [most probably] zero; end of contemplation..... but not of interest. Even microbes existing kilometers deep in the crust have been accessed by our probing technology, and there is also a booming intellectual industry devoted to discovering the existence of life, intelligent life, beyond earth. [If and when we make contact with extraterrestrial life-supporting environments, our environmental influence, no matter how weak at the time, will also represent an alteration of yet another type of environment.] The point here is that not only are we intruders into all manner of earth environments and those beyond, but that we are also part of all those environments into which we have inserted ourselves directly or indirectly, *and we cannot entangle ourselves from them because of our intrusion*. Environmental study then implies at least a portion of that study being holistic in nature.

This notion of holism applies particularly to our understanding and effective stewardship of the urban forest. Too often we find an us-and-them attitude about the aspects of our urban forest that do not bring us immediate reward rather than having a sense of responsibility, attachment, engagement, and involvement in the totality of all the environments including the urban forest to which we are a part. This is particularly true with regard to our niche constructing capacities; we alter or create environments that then feed back on us. The invention of the shower and then the colonization of the aerosol environment due to shower spray by *Legionella*, the pathogen causing Legionaires' Disease, is a prime example of such niche construction. How we modify our urban forest, even by default of appropriate stewardship, should and must be a point of interest if not a bonafide concern.

HEROS OF THE URBAN FOREST:

There are two groups of people who should be recognized for their ongoing work in support of the urban forest. First of course are those either formally or informally who work specifically to maintain and expand the urban forest. In no particular order are all interested parties either formally or informally who have devoted time to the upkeep of the UF. Of the former category are all members everywhere on official Tree Commissions, Lake Zurich's Tree commissioners certainly, but every member nationally. It should also be noted that the Lake Zurich Ancient Oaks Society falls into this category. And then there is a select group who by their support of urban and suburban gardens enhance the general environment of which the urban forest is a part. DRIP LINE POLICY & PERSPECTIVE:

The intent of this embryonic publication is to inform about pertinent issues regarding the urban forest. This intent is broad-based, and specific selection of what is or is not to appear in THE DRIP LINE will remain solely in the hands of the staff....that would be me, Tony Harper. The ecological perspective of this missive is bio-cultural, i.e. that we are part of the environmental system, the earth-system/world-system complex. As a consequence, there can be no us-versus-them stance with respect to what is and what is not *natural*; we, among the organisms of the world, are all part of the same system. As a consequence, the topics reported on here will have the perspective of holism. Further, and this is mildly heretical, this missive takes the perspective that conservation efforts are short-term and stop-gap at best; conservation efforts, as important as they are, do NOT address the roots of our 21st Century environmental problems *per se*. These problems are *wicked* problems in the academic sense of the word, and as a result, they will require interdisciplinary efforts for their resolution, i.e. the efforts not only of ecologists and environmentalists but of economists, members of the business community, and more generally of the L.Z. populace (and beyond) at large.
