## MINUTES OF A SPECIAL MEETING OF THE BOARD OF TRUSTEES JUNE 13, 2022

A special meeting of the Lake Zurich Firefighters' Pension Fund was held on Monday, June 13, 2022 at 8:00 a.m. via video conference without a quorum of the public body physically present at the Board's regular meeting location because of a disaster declaration related to COVID-19 public health concerns affecting the Village of Lake Zurich. The Lake Zurich Firefighters' Pension Fund Board President has determined that an in-person meeting with all participants is not practical, prudent or feasible because of the disaster. The regular meeting is set for the purposes in the following agenda:

**CALL TO ORDER:** Trustee Cornell called the meeting to order at 8:00 a.m.

**DISCUSSION/POSSIBLE ACTION – FIDUCIARY LIABILITY INSURANCE BROKER CHANGE:** Mr. Kiesewetter provided the Board with an overview of Cook Castle Associates, LLC fiduciary liability insurance services and discussed the process for changing brokers. A motion was made by Trustee Cornell and seconded by Trustee Fuchs to engage Cook Castle Associates, LLC as Lake Zurich Firefighters' Pension Funds' Fiduciary Liability Insurance broker.
