C. Ordinance Establishing Village of Lake Zurich Special Service Area #20 at the Sanctuary of Lake Zurich Subdivision (Assign Ord. #2023-05-512)

Summary: This backup Special Service Area is being established for the maintenance and reconstruction of certain improvements within the Sanctuary of Lake Zurich Subdivision in the event they are necessary. This backup SSA was required as a condition of the Development Agreement between the Village and LZ Development Group, LLC. On February 21, 2023, the Village Board conducted the required Public Hearing to propose the establishment of the backup SSA. No objecting petition was filed within 60 days of that public hearing and the SSA may now therefore be approved.

D. Agreement with Patriot Pavement Maintenance, Inc. for the 2023 Pavement Crack Sealing Program in the Amount Not-to-Exceed \$60,000

Summary: The FY23 budget includes \$60,000 in the Motor Fuel Tax Fund for preventative street maintenance. A cooperative bid opening with the Lake County Municipal League on April 14, 2023 resulted in three bids received, with the most competitive bid from Patriot Pavement Maintenance.

E. Change Order Request with Layne Christensen Company for Updated Well #12 Preventative Maintenance in the Amount Not-to-Exceed \$204,400

Summary: In September 2022, the Village Board authorized preventative maintenance for Well #12 with its designated deep well contractor, Layne Christensen Company for an amount not-to-exceed \$154,000 from the FY22 budget. The maintenance project began on November 14, 2022 and due to unanticipated conditions discovered, additional costs will be incurred in order to complete the project.

Due to the uncertainty of the time necessary to reopen the borehole, staff is recommending adding a \$10,000 contingency for a project total of \$204,400, an overage of \$50,400 from the original authorized amount. The FY23 budget includes \$130,000 funding for Well #7 scheduled maintenance that staff is recommending to defer to FY 2024 in order to account for the increase in the cost of the Well 12 maintenance project.

F. Intergovernmental Cooperation Agreement for the Purpose of a Shared Training Simulator between the Village of Vernon Hills and Local Law Enforcement Partners

Summary: The LZPD has participated in a cooperative arrangement for the use of a scenario-based decision-making simulator system with five area police departments for nearly 20 years. The current system has become outdated and has experienced operational issues that have made it obsolete.

8. NEW BUSINESS

A. Agreement with Arrow Road Construction Company for the 2023 Road Resurfacing Program in the Amount Not-to-Exceed \$2,742,061.01 (Trustee Spaccone)

Summary: The FY 2023 budget includes \$3.2 million in the Motor Fuel Tax Fund for the annual road resurfacing program. Traditionally, the road resurfacing program is funded almost entirely by the local 0.5% non-home rule sales tax. For this year's program, infrastructure funding from Federal and State grant programs allows the Village to dedicate an additional \$1.29 million in resurfacing funds.

2023 road resurfacing will include the eastern portion of the Old Mill Grove subdivision, including Old Mill Grove Road in its entirety. Other roads slated for resurfacing include Brush Hill Lane, Browning Lane, Millbrook Drive, Kingwood Lane, Heartwood Lane, Pebble Creek Drive, and Ridgewood Court.

A competitive bid opening on April 14, 2023 resulted in five bids received, with the lowest responsible bid from Arrow Road Construction Company with a base bid amount of \$2,356,419.10. The total requested authorization amount of \$2,742,061.01 includes the base bid plus \$385,641.91 for engineering, materials testing, and additional project contingency.

Recommended Action: A motion to approve an Agreement with Arrow Road Construction Company for the 2023 Road Resurfacing Program in the Amount Not-to-Exceed \$2,742,061.01.

Summary: The FY 2023 budget includes \$27,000 in the Non-Home Rule Sales Tax Fund for this year's asphalt patching repairs. Asphalt materials are used for in-house repairs by Public Works crews. A competitive bid opening on March 30, 2023 resulted in two bids received, with Geske and Sons as the most competitive price.

- D. Agreement with Chicagoland Paving Contractors for 2023 Street Patching Program in the Amount Not-to-Exceed \$100,000

Summary: The FY 2023 budget includes \$100,000 in the Non-Home Rule Sales Tax Fund for this year's street resurfacing program. The Village has historically participated in a cooperative bid arrangement to secure a more competitive price. In January 2023, the Lake County Municipal League approved the final extension per the approved April 21, 2020 contract.

- E. Ordinance Authorizing Disposal of Surplus Property Owned by the Village of Lake Zurich ORD. #2023-04-509

Summary: Staff has identified pieces of equipment that are not in working order, would require repairs in excess of present market value, or are obsolete.

Ordinance Approving an Adjustment to the Final Plan through Amendment of Ordinance #2020-09-384 for Rear Yard Setback Encroachment at Wildwood Estates of Lake Zurich on Honey Lake Road ORD. #2023-04-510

Summary: Wildwood of Lake Zurich, LLC has filed an Adjustment to the Final Plan for the Wildwood Estates development to allow certain structures to encroach into the rear yard setback of all lots within the Subdivision. This Planned Unit Development was approved for the construction of 24 duplex homes on 12 lots in September 2020. The developer is requesting allowance for decks and other structures to encroach no more than 10 feet into the required rear-yard setbacks that back up to the 28 acres of open space and wetlands.

- F. Ordinance Approving an Adjustment to the Final Plan through Amendment of Ordinance #2021-07-421 for the Enlargement of Piers at Sanctuary of Lake Zurich on the Southeast Corner of Rand Road and Old Rand Road ORD. #2023-04-511

Summary: LZ Development Group, LLC has filed an Adjustment to the Final Plan for the Sanctuary development to enlarge the approved pier size for the three previously approved boat piers containing 30 boat slips. This Planned Unit Development was approved for the construction of a commercial building and 23 new townhouse buildings in July 2021. The developer is requesting an increase in the projection from the shoreline from a max distance of 75 feet to 84 feet and an increase in the pier deck area from a max of 400 square feet to 702 square feet.

The Planning and Zoning Commission reviewed this application at a public hearing on March 15, 2023. Representatives from the Sandy Point HOA and the LPOA were present and voiced their support for the application. There were no objections to the proposal from any adjacent property owners and the Commission voted 7-0 to recommend approval of the enlarged piers.

The following Agenda Item was pulled by the Petitioner.

Event Approval for Stephen Siller Tunnel to Towers 5k on June 11, 2023 at Breezewald Park

Summary: Due to the pending Main Street District infrastructure projects planned for this year, this annual race will not be able to utilize the typical route around the lake. A revised route to and from Breezewald Park has been created that does not require full street closure nor use of State or County jurisdiction roads.

G Agreement with Davey Resource Group Inc. for 2023 Natural Area Maintenance in the Amount Not-to-Exceed \$89,434

Summary: Lake Zurich has partnered with Integrated Lakes Management to formulate five-year plans for the maintenance and restoration of natural areas throughout the Village. The FY 2023 budget includes sufficient funding for the maintenance of these open space areas when combined with revenue held in special service area accounts designed specifically for the maintenance of designated areas in specific subdivisions. A competitive bid opening on March 23, 2023 resulted in two bids received, with Davey Resource Group as the most competitive price.

7. NEW BUSINESS

A. **Ordinance Approving a Tax Increment Finance Development Agreement Between the Village of Lake Zurich and JGS Lake Zurich West, LLC ORD. #2023-04-512**

Summary: The Lake Zurich Industrial TIF District was created in January 2023 by the Village Board, after the review and unanimous approval of the Joint Review Board, for the purpose of providing a long-term funding mechanism for infrastructure improvements within the industrial park and supporting business expansion and modernization efforts.

JGS Lake Zurich West, LLC is requesting TIF assistance related to the implementation of a new manufacturing line at 550 Enterprise Parkway. The company is considering this location for manufacturing equipment upgrades which would increase the overall investment in the community and create 8 – 10 full-time positions.

JGS Lake Zurich West, LLC is a component of Geremarie, a company that has been operating in the Lake Zurich industrial park at 1275 Ensell Road manufacturing aluminum components for over 20 years. Since its initial decision over two decades ago to be in Lake Zurich, Geremarie has built several additions to the building as it has seen increased demand for its product.

JGS Lake Zurich West's total project costs for the new development at 550 Enterprise Parkway is no less than \$8.5 million, including the cost of the land, site work, engineering and construction, permit fees, the installation of manufacturing line equipment, and electric/gas utility connections.

The proposed TIF redevelopment proposal will help offset this significant investment cost with a rebate of \$626,000 of future property taxes over several years through the Tax Increment Finance District #4 (Industrial TIF), which equates to approximately 7.4% of the overall costs of this manufacturing company expansion project.

Asst. to the Village Manager, Kyle Kordell, gave an explanation of the proposal and answered the Board's questions.

Recommended Action: A motion was made by Trustee Sprawka, seconded by Trustee Euker, to approve Ordinance #2023-04-512 Approving a Tax Increment Finance Redevelopment Agreement by and Between the Village of Lake Zurich, Lake County, Illinois and JGS Lake Zurich West, LLC.

B. Agreement with Teska Associates for Comprehensive Plan Update in the Amount Not-to-Exceed \$119,555

Summary: A municipal comprehensive plan is used to identify recent and forthcoming land use patterns and economic development trends to chart a path forward for continued smart growth over the next 10-20 years. Lake Zurich's comprehensive plan was last updated in 2003 and needs updated so that Lake Zurich can maximize its reputation as being a safe community where families want to raise children and businesses want to operate.

A request-for-proposals was launched in January 2023, resulting in two proposals to consider. Both proposals include a process of community assessment, engagement, analysis, visioning, goals, community branding, and plan preparation. However, one proposal is \$33,000 less expensive than the other and therefore Staff is recommending Teska Associates as the selected consultant to lead this process.

The FY 2023 budget currently includes \$50,000 in the General Fund for an update to the Comprehensive Plan. The Teska proposal is \$119,555, necessitating additional funding of approximately \$70,000 in the FY 2023 budget. Staff will include the additional \$70,000 in a future budget amendment ordinance for Board consideration.

Mr. Lee Brown, Teska Assocs., introduced the staff who will be working on the Plan and the team gave a PowerPoint presentation of the proposed plan. Feedback from the Board included community engagement to include young families, transportation including linking bike lanes to Barrington, internet speed village wide, timeline, among other concerns. Mr. Brown and staff answered the questions.

Recommended Action: A motion was made by Trustee Bobrowski, seconded by Trustee Spacone, to approve an agreement with Teska Associates for Comprehensive Plan update in the Amount Not-to-Exceed \$119,555 and to direct Staff to include the additional \$70,000 needed in a future budget amendment.

Re: **Ordinance Establishing Backup Special Service Area No. 20
Sanctuary of Lake Zurich Subdivision**

Issue: An ordinance establishing a backup Special Service Area No 20 (SSA No. 20) for maintaining, repairing, reconstructing and/or replacing certain improvements within the Sanctuary of Lake Zurich Subdivision including but not limited to the following – wetland areas, lakefront beaches, lakefront shoreline, underground detention and vortex, storm sewer maintenance, and special projects including retaining walls and private roadways (hereinafter referred to as the “Improvements”) located within the property commonly referred to as the Sanctuary of Lake Zurich (the “Subject Property”). No levy of taxes is proposed at this time.

The backup SSA was required as a condition within the Development Agreement between the Village of Lake Zurich and developer, LZ Development Group, LLC represented by Mr. Romeo Kapudija, for the redevelopment of the property.

Village Strategic Plan: This agenda item is consistent with the following objectives under Goal #2 – Development:

- Expand the Village’s role as a major regional economic hub in Lake County
- Continue Route 12 (Rand Road) Corridor Development
- Become more business friendly and customer oriented.

Background: On February 21, 2023, the Village Board conducted the required public hearing to propose the establishment of the backup SSA. Following the close of the public hearing, the

required comment period of 60 days commenced. Within that period, any petition to veto (object to) the backup SSA would need to be submitted. If vetoed, the SSA would not be re-proposed by the Village for two years. However, no such petition was filed within the required 60 days, and the developer signed a waiver to file any objection to the backup SSA. As such, staff finds that no further public hearings need to be conducted. The ordinance establishing the backup SSA may therefore be approved.

Analysis: Because taxes will not be levied until the Village actually takes action to remedy the HOA's obligations and expends funds for the implementation of these Special Services, the line item for the SSA will show up on a property owner's tax bill with a tax rate of zero. In the event a tax is levied for work conducted by the village, any such initial tax levy shall not exceed a maximum tax rate as follows:

- A tax levy at a rate not to exceed \$0.847 per \$100.00 of equalized assessed valuation of the Residential Townhouse Properties for the year in which village expends funds to conduct the repairs/improvements;
- A tax levy at a rate not to exceed \$2.874 per \$100.00 of equalized assessed valuation of the Restaurant Property for the year in which village expends funds to conduct the repairs/improvements.

At that time, a public hearing will need to be conducted by the Village Board to activate the SSA and impose the tax levy.

The tax rates are estimated to generate an average of \$38,692.17 per year in maintenance costs for a time period of 30 years to be shared by the 23 single-family townhouses on the property and the restaurant with an average market value of \$900,000 and the restaurant on the property with an average market value of \$2,100,000.

This SSA will allow the Village to assess a tax, in the future and only if necessary, on the property owners of the townhouses and restaurant property within that subdivision to pay for maintenance and repairs to the improvements, and only in the event the subdivision's Homeowners Association (HOA) and restaurant owner is delinquent in fulfilling these obligations.

Recommendation: Staff recommends that the Village Board approve the ordinance establishing backup SSA No 20.

**ORDINANCE No. 2023-05-512****AN ORDINANCE ESTABLISHING VILLAGE OF
LAKE ZURICH SPECIAL SERVICE AREA NUMBER 20**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lake Zurich, Lake County, Illinois, as follows:

SECTION 1: AUTHORITY. Special Service Area Number 20 is established pursuant to the provisions of Article VII, Section 7 of the Constitution of the State of Illinois, and pursuant to the provisions of the Special Service Area Tax Law, 35 ILCS 200/27-5 *et seq.*

SECTION 2: FINDINGS. The Village Board finds:

- A. The question of the establishment of the area hereinafter described as a special service area was considered by the President and Board of Trustees (hereinafter the "Village Board") pursuant to Ordinance No 2023-02-501 entitled: "An Ordinance Proposing the Establishment of a Special Service Area Number 20 in the Village of Lake Zurich, and Providing for a Public Hearing and Other Procedures in Connection Therewith," adopted February 21, 2023, and was considered pursuant to a hearing held on February 21, 2023 by the Village Board pursuant to a Newspaper Notice duly published in *the Daily Herald*, a newspaper published in the Village of Lake Zurich (hereinafter the "Village"), at least fifteen (15) days prior to the hearing, and pursuant to Personal Notice by mail addressed to the person or persons in whose name the general taxes for the last preceding year were paid on each lot, block, tract or parcel of land lying within the special service area. Said Personal Notice by mail was given by depositing said Personal Notice in the United States mail not less than ten (10) days prior to the time set for the public hearing. A Certificate of Publication of said Newspaper Notice and an Affidavit of Mailing of said Personal Notice are attached to this Ordinance as Exhibit 1 and Exhibit 2, respectively, and made part hereof. Said Newspaper Notice and Personal Notice conformed in all respects to the requirements of Section 27-25 of the Special Service Area Tax Law (35 ILCS 200/27-25).
- B. That a public hearing on the question set forth in the Newspaper Notice and Personal Notice was held on February 21, 2023. All interested persons were given an opportunity to be heard on the question of the creation of the special service

area, and the levy of an annual tax to pay for the proposed Special Services (as defined in Section 4 below), as set forth in the Newspaper Notice and Personal Notice. The public hearing was opened on February 21, 2023, and there was final adjournment thereof on February 21, 2023, as part of the regular Lake Zurich Village Board meeting on said date.

- C. That after considering the data, as presented at the public hearing, the Village Board finds that it is in the public interest and in the interest of the Village of Lake Zurich Special Service Area Number 20 that said special service area, as hereinafter described, be established.
- D. That the area hereinafter described is compact and contiguous, and said area lies within and is approved as a Planned Unit Development (PUD) for a Townhouse (single-family attached) development within the R-6 multiple-family residential district and a commercial restaurant development within the B-1 local and community business district, in the Village of Lake Zurich (the "Village").
- E. It is in the best interest of said special service area that the furnishing of the municipal services proposed be considered for the common interests of said area.
- F. That the area hereinafter described will benefit specifically from the municipal services to be provided, and that the proposed municipal services are unique and in addition to municipal services provided to the Village as a whole, and it is, therefore, in the best interests of the Village that the expenditure of funds by the Village, and the levy of special taxes against said area, for the services to be provided, be considered.

SECTION 3: VILLAGE OF LAKE ZURICH SPECIAL SERVICE AREA NUMBER 20 ESTABLISHED.

- A. A special service area to be known and designated as "Village of Lake Zurich Special Service Area Number 20" (hereinafter "Special Service Area Number 20") is hereby established and shall consist of the following-described territory:

The Sanctuary of Lake Zurich Subdivision described as being a subdivision in part of the Southeast Quarter of Section 18, Township 43 North, Range 10, East of the Third Principal Meridian, Lake County, Illinois, recorded with the Lake County Recorder of Deeds on October 3, 2022 as document number 7936523;

(hereinafter the “Special Services”), within said Special Service Area Number 20.

In the event that the Village is required to expend funds relative to said Special Services, the Village shall levy a direct annual tax as follows:

- For properties designated as “Residential Townhouse Properties,” “Common open space around Residential Townhouse Properties including the lake shore and lake bottom property” and “Common Building Areas – Sprinkler/Meter Rooms”:
A tax levy at a rate not to exceed \$0.847 per \$100.00 of equalized assessed valuation of such property;
- For property designated as “Restaurant Property”
A tax levy at a rate not to exceed \$2.874 per \$100.00 of equalized assessed valuation of such property.

in Special Service Area Number 20, for each year during which the Village of Lake Zurich is required to expend funds relative to said Special Services, so long as the stormwater management improvements and/or roadway improvements, as referenced above, exist, will be considered at the public hearing. As taxes will not be levied until such time, if any, as the Village actually expends funds for said Special Services, it is currently unknown as to the actual amount of the taxes that will be levied for the initial year, if any, for which taxes will be levied within Special Service Area Number 20; however, any such initial tax levy shall not exceed the maximum tax rate as set forth above. Said tax is to be levied upon all taxable property within the proposed Special Service Area Number 20 and shall be in addition to all other taxes provided by law.

SECTION 5: EFFECTIVE DATE.

The Village is in receipt of a “Waiver of Right to File an Objection Petition Opposing the Creation of Village of Lake Zurich Special Service Area Number 20 (A copy of which is attached hereto as Exhibit 4 and made part hereof. As such, and as there are no electors residing within the Subject Property, and as Owner is the sole owner of the Subject Property, this Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as required by law. The Village Clerk is hereby directed and ordered to file a certified copy of this Ordinance with the Lake County Clerk, and record a certified copy of this Ordinance with the Lake County Recorder’s Office, within sixty (60) days of the effective date hereof.



Subject: **2023 Crack Sealing (LCML Cooperative Bid)
Award Recommendation**

Issue: The FY 2023 budget includes \$60,000 in the Motor Fuel Tax (MFT) fund for preventive street maintenance.

Village Strategic Plan: This agenda item is consistent with the following Goals and Objectives of the Strategic Plan.

- *Infrastructure Investment:* Develop and formalize a long-range street maintenance program.

Background: In order for the Village to receive a return on investment for the significant investment made on its annual street resurfacing program, a street maintenance program is necessary. The preferred method of crack sealing addresses the freeze/thaw cycles that cause bituminous asphalt to become brittle and develop cracks.

If left untreated, these cracks introduce moisture to the pavement structure which leads to premature pavement deterioration and higher reconstruction costs. A crack sealing program is typically introduced three to five years after a street is resurfaced and can add 10 years to the life of a street.

Analysis: The Village has historically participated in a cooperative bid agreement with other municipalities through the Lake County Municipal League (LCML). Doing so allows the Village to secure a more competitive unit price. The LCML Crack Sealing program was bid on April 14, 2023. It is a one (1) year contract with an option to extend the contract for five (5) additional single years.



1. Interpretation of Documents and Governing Standards

A. **Defined Terms.** All terms capitalized in these General Instructions to Bidders and in the other documents included in the Bid Package are defined in the documents included in the Bid Package and shall have such defined meanings wherever used.

B. **Implied Terms.** If any personnel, equipment, materials, or supplies that are not directly or indirectly set forth in the Contract are nevertheless necessary to the proper provision, performance, and completion of the whole of the Work in accordance with the intent of the Contract, each prospective Bidder shall understand such personnel, equipment, materials, or supplies to be implied and shall provide for such personnel, equipment, materials, or supplies in its Bidder's Proposal as fully as if it were particularly described.

C. **Information Provided by Owner.** When information pertaining to subsurface, underground or other concealed conditions, soils analysis, borings, test pits, utility locations or conditions, buried structures, condition of existing structures, and other preliminary investigations is distributed with the Bid Package, or such information is otherwise made available to any prospective Bidder by Owner, such information is distributed or made available solely for the convenience of such prospective Bidder and is not part of the Bid Package. Owner assumes no responsibility whatever in respect to the sufficiency or accuracy of any such information, and there is no guaranty or warranty, either expressed or implied, that the conditions indicated are representative of those existing throughout the Work or the Work Site, or that the conditions indicated are representative of those existing at any particular location, or that unanticipated conditions may not be present.

D. **Addenda.** No interpretation of the documents included within the Bid Package will be made except by written addendum duly issued by Owner ("Addendum"). No interpretation not contained in an Addendum shall be valid or have any force or effect whatever, nor entitle any Bidder to assert any claim or demand against Owner on account thereof.

All Addenda issued prior to the opening of Bidder's Proposals shall become a part of the Bid Package. Each prospective Bidder shall be responsible for inquiring from time to time as to the availability of Addenda.

Bridge Construction, Adopted January 1, 2012, and the accompanying Supplemental Specification and Recurring Special Provisions, Adopted January 1, 2015 are adopted and are included herein.

2. Calculation of Unit Price Proposals

On all items for which Bidder's Proposals are to be received on a unit price basis, the approximate quantities stated in the Schedule of Prices are Owner's estimate only for Owner's convenience in comparing Bidder's Proposals and shall not be relied upon by prospective Bidders. Each prospective Bidder shall, before submitting its Bidder's Proposal, make its own estimate of the quantities of Unit Price Items required to complete the Work and shall determine its Price Proposal for each Unit Price Item in light of its own estimate.

3. Prevailing Wages

In accordance with the Prevailing Wage Act, 820 ILCS 130/0.01 *et seq.*, not less than the prevailing rate of wages for similar work in the locality in which the Work is to be performed shall be paid to all laborers. If the Illinois Department of Labor revises the prevailing rate of hourly wages to be paid, the revised rate shall apply to the Contract.

It shall be the sole responsibility of each prospective Bidder to determine the applicable permits, licenses, and other approvals and authorizations and no extra compensation shall be paid by Owner for the successful Bidder's failure to include these costs in its Bidder's Proposal.

GENERAL INSTRUCTIONS

6. Preparation of Bidder's Proposal

Bidder's Proposals to enter into the Contract for the Work shall be made only on the blank Bidder's Proposal form furnished by Owner and included in the Bid Package (Part II). The Bidder's Proposal form included in the Bid Package shall be removed from the Bid Package prior to preparation for submission.

Entries on the Bidder's Proposal form shall be typed or legibly written in ink. Price Proposals are to be written by words and by figures as provided on the Bidder's Proposal form. In case of any conflict, words shall prevail. In case of any error in adding or multiplying individual items, the prices listed for individual items shall control over any incorrect total of such items. A Bidder's Proposal may be rejected if it does not contain a requested price for each and every item named in the Bidder's Proposal form or may be interpreted as bidding "no charge" to Owner for any item left blank.

Prospective Bidders are warned against making alterations of any kind to the Bidder's Proposal form or to any entry thereon. Bidder's Proposals that contain omissions, conditions, alterations, or additions not called for may be rejected or interpreted so as to be most favorable to Owner.

Each Bidder shall securely staple into its Bidder's Proposal a copy of each Addendum issued and shall include in the place provided therefor in the Bidder's Proposal form a listing of all such Addenda.

Each Bidder shall complete and securely staple into its Bidder's Proposal the Bidder's Sworn Acknowledgement and the Bidder's Sworn Work History Statement included in the Bid Package, and shall staple into its Bidder's Proposal the Bid Security and the surety.

Every Bidder submitting a Bidder's Proposal shall be conclusively deemed to have evidenced an intention to be bound thereby whether or not the requirements for signing Bidder's Proposals found in Section 7 of these General Instructions to Bidders are satisfied. However, any Bidder's Proposal that fails to comply with Section 7 of these General Instructions to Bidders may nevertheless be rejected.

Bidder's Proposals that are not submitted on the Bidder's Proposal form furnished by Owner or that are not prepared in accordance with these General Instructions to Bidders may be rejected. If a deficiently prepared Bidder's Proposal is not rejected, Owner may demand correction of any deficiency and award the Contract to Bidder upon satisfactory compliance with these General Instructions to Bidders.

7. Signature Requirements

A. Bidder's Proposals. The following requirements shall be observed in the signing of each Bidder's Proposal:

GENERAL INSTRUCTIONS

- (1) **Corporations.** Each Bidder's Proposal submitted by a corporation shall be signed by the President or other authorized officer of the corporation and shall also bear the attesting signature of the Secretary or Assistant Secretary of the corporation.
- (2) **Partnerships.** Each Bidder's Proposal submitted by a partnership shall be signed by all of its general partners or by an attorney-in-fact.
- (3) **Individuals.** Each Bidder's Proposal submitted by an individual shall be signed by such individual or by an attorney-in-fact.

When requested by Owner, satisfactory evidence of the authority of the person or persons signing on behalf of Bidder shall be furnished.

B. **Other Documents.** The signature requirements set forth in Subsection 7A shall apply to all other documents in the Bid Package required to be executed by Bidder, Bidder's sureties and Bidder's insurance representatives as well as to the Contract, the Contractor's Certification, and all other required documentation related to the Contract.

8. Bid Security

A. **Required Bid Security.** Every Bidder's Proposal shall be accompanied by bid security in the form of a Cashier's Check, Certified Check, Bid Bond or cash as specified in the Invitation for Bidder's Proposals ("Bid Security"), which Bid Security shall stand as a guaranty that (1) Bidder will submit all additional information requested by Owner; (2) if such Bidder's Proposal is accepted, Bidder will timely file the Bonds and the certificates and policies of insurance required by the Contract; and (3) if such Bidder's Proposal is accepted, Bidder will timely execute the Contract, the Contractor's Certification, and all other required documentation related to the Contract.

B. **Return of Bid Security.** Bid Security submitted in the form of Cashier's Checks, Certified Checks or cash will be returned within five (5) days after execution of the Contract by Owner. Bid Bonds will not be returned unless otherwise requested by Bidder.

C. **Liquidated Damages.** If a Bidder fails to timely submit all additional information requested by Owner, or if the successful Bidder fails to timely and properly submit all required Bonds, certificates and policies of insurance, or if the successful Bidder fails to timely and properly execute the Contract, the Contractor's Certification, and all other required documentation related to the Contract, it will be difficult and impracticable to ascertain and

determine the amount of damage that Owner will sustain by reason of any such failure. For such reason, every Bidder shall, by submitting its Bidder's Proposal, be deemed to agree that Owner shall have the right, at its option in the event of any such default, to retain or recover as reasonably estimated liquidated damages, and not as a penalty, the entire amount of the Bid Security or ten percent of the Bidder's Price Proposal, whichever is greater, or to exercise any and all equitable remedies it may have against the defaulting Bidder.

9. Submission of Bidder's Proposal

One copy of each Bidder's Proposal, properly signed, together with all other required documents, shall be enclosed in a sealed envelope or package and shall be addressed and delivered to the place, before the time, and in the manner designated in the Public Notice/Instructions to Bidders. All Bidder's Proposals received after the time for the opening of bids specified in the Public Notice/Instructions to Bidders will be returned unopened. Each sealed envelope or package containing a Bidder's Proposal shall be identified as such and shall be marked with the title of the Contract and Bidder's full legal name. All Addenda will be considered part of each Bidder's Proposal whether attached or not.

10. Withdrawal of Bidder's Proposal

Any Bidder's Proposal may be withdrawn at any time prior to the opening of any Bidder's Proposal, provided that a request in writing, executed by Bidder, for the withdrawal of such Bidder's Proposal is filed with Owner prior to the opening of any Bidder's Proposal. The withdrawal of a Bidder's Proposal prior to opening of any Bidder's Proposal will not prejudice the right of Bidder to file a new Bidder's Proposal.

No Bidder's Proposal shall be withdrawn without the consent of Owner for a period of sixty (60) days after the opening of any Bidder's Proposal. Any Bidder's Proposal may be withdrawn at any time following the expiration of said sixty (60) day period, provided that a request in writing, executed by Bidder, for the withdrawal of such Bidder's Proposal is filed with Owner after said sixty (60) day period. If no such request is filed, the date for acceptance of such Bidder's Proposal shall be deemed to be extended until such a request is filed or until Owner executes a Contract pursuant to the Invitation for Bidder's Proposals or until Owner affirmatively and in writing rejects such Bidder's Proposal.

11. Qualification of Bidders

A. Factors. Owner intends to award the Contract only to a Bidder that furnishes satisfactory evidence that it has the requisite experience, ability, capital, facilities, plant, organization and staffing to enable it to perform the Work successfully and promptly and to complete the Work for the Contract Price and within the Contract Time.

B. Additional Information. Owner reserves the right to require from any Bidder, prior to award of the Contract, a detailed statement regarding the business and technical organizations and plan of Bidder that is available for the Work. Information pertaining to financial

resources, experience of personnel, contract defaults, litigation history, and pending construction projects may also be requested.

C. **Final Determination.** The final selection of the successful Bidder shall be made on the basis of the amount of the Bidder's Price Proposals, Owner's prior experience with the Bidders, Owner's knowledge of the Bidders' performance on other relevant projects, any additional information submitted by Bidders to satisfy Owner that Bidders are adequately prepared to fulfill the Contract, and all other relevant facts or matters mentioned in the Bid Package or that Owner may legally consider in making its determination.

12. Disqualification of Bidders

A. **More Than One Bidder's Proposal.** No more than one Bidder's Proposal for the Work described in the Contract shall be considered from any single corporation, partnership, individual or joint venture, whether under the same or different names and whether or not in conjunction with any other corporation, partnership, individual or joint venture. Reasonable grounds for believing that any corporation, partnership, individual or joint venture is interested in more than one Bidder's Proposal for the Work may cause the rejection of all Bidder's Proposals in which such corporation, partnership, individual or joint venture is interested. Nothing contained in this Subsection 12A shall prohibit any single corporation, partnership, individual or joint venture, whether under the same or different names and whether or not in conjunction with any other corporation, partnership, individual or joint venture, from submitting a bid or quoting prices to more than one Bidder for equipment, materials and supplies or labor to be furnished as a subcontractor or supplier.

B. **Collusion.** If there are reasonable grounds for believing that collusion exists among any Bidders, all Bidder's Proposals of the participants in such collusion will not be considered.

C. **Default.** If a Bidder is or has been in default on a contract with Owner or in the payment of monies due Owner, its Bidder's Proposal will not be considered.

13. Award of Contract

A. **Reservation of Rights.** Owner reserves the right to accept the Bidder's Proposal that is, in its judgment, the best and most favorable to the interests of Owner and the public; to reject the low Price Proposal; to accept any item of any Bidder's Proposal; to reject any and all Bidder's Proposals; to accept and incorporate corrections, clarifications or modifications following the opening of the Bidder's Proposals when to do so would not, in Owner's opinion, prejudice the bidding process or create any improper advantage to any Bidder; and to waive irregularities and informalities in the bidding process or in any Bidder's Proposal submitted; provided, however, that the waiver of any prior defect or informality shall not be considered a waiver of any future or similar defects or informalities, and Bidders should not rely upon, or anticipate, such waivers in submitting their Bidder's Proposals.

GENERAL INSTRUCTIONS

B. **Firm Offers.** All Bidder's Proposals are firm offers to enter into the Contract and no Bidder's Proposals shall be deemed rejected, notwithstanding acceptance of any other Bidder's Proposal, until the Contract has been executed by both Owner and the successful Bidder or until Owner affirmatively and in writing rejects such Bidder's Proposal.

C. **Time of Award.** It is expected that the award of the Contract, if it is awarded, will be made within sixty (60) days following the opening of the Bidder's Proposals. Should administrative difficulties be encountered after the opening of the Bidder's Proposals including the annulment of any award, that may delay an award or subsequent award beyond such sixty (60) day period, Owner may accept any Bidder's Proposal for which the date for acceptance has been extended as provided in Section 10 of these General Instructions to Bidders in order to avoid the need for re-advertisement. No Bidder shall be under any obligation to extend the date for acceptance of its Bidder's Proposal. Failure of one or more of the Bidders or their sureties to extend the date for acceptance of its Bidder's Proposal shall not prejudice the right of Owner to accept any Bidder's Proposal for which the date for acceptance has been extended.

14. Notice of Award; Effective Date of Award

If the Contract is awarded by Owner, such award shall be effective when a Notice of Award has been delivered to the successful Bidder ("Effective Date of Award"). Owner will prepare five (5) copies of the Contract based upon Bidder's Proposal and will submit them to the successful Bidder with the Notice of Award.

15. Closing of Contract

A. **Closing Date.** Unless otherwise stated in the Notice of Award, the successful Bidder shall satisfactorily complete all Conditions Precedent to Closing before, and the Contract and all related documents shall be executed, submitted and exchanged by Owner and Bidder ("Closing") on, the tenth day following the Effective Date of Award or within such extended period as Owner may, in the exercise of its sole discretion, authorize in writing after issuance of the Notice of Award ("Closing Date").

B. **Conditions Precedent to Closing.** On or before the Closing Date, the successful Bidder shall: (1) sign (see Section 7), date as of the Closing Date, and submit to Owner all five copies of the Contract, the Contractor's Certification, and all other required documentation related to the Contract on or before the Closing Date; and (2) submit five executed copies of all required Bonds dated as of the Closing Date and all certificates and policies of insurance.

Failure to timely execute or submit any of the aforesaid documents shall be grounds for the imposition of liquidated damages as more specifically set forth in Section 8 above. If the submitted documents or any of them fail to comply with these General Instructions to Bidders or the Contract or are not timely executed and submitted, Owner may, in its sole discretion, annul the award or allow the successful Bidder an opportunity to correct the deficiencies.

GENERAL INSTRUCTIONS

In no event will Owner execute the Contract until any and all such deficiencies have been cured or Owner has received adequate assurances, as determined by Owner, of complete and prompt performance.

C. Closing. At the Closing, and provided that all documents required to be submitted prior to or at the Closing have been reviewed and determined by Owner to be in compliance with these General Instructions to Bidders and the Contract, or assurances of complete and prompt performance satisfactory to Owner have been received, Owner shall execute all copies of the Contract, retain three copies of the completed Contract, and tender two copies to the successful Bidder at the Closing. The successful Bidder shall tender one copy to its surety company or companies. The successful Bidder or its agent shall be present at the Closing.

16. Failure to Close

A. Annulment of Award; Liquidated Damages. The failure or refusal of a successful Bidder to comply with the Conditions Precedent to Closing or to Close shall be just cause for the annulment of the award and the imposition of liquidated damages or the exercise of equitable remedies, both as more specifically set forth in Section 8 above.

B. Subsequent Awards. Upon annulment of an award, Owner may accept, and award a Contract based on, any other Bidder's Proposal as Owner, in its sole judgment, deems to be the best or may invite new Proposals or may abandon the bidding process or the Work.

17. Basis for Determining Prices

It is expressly understood and agreed that:

1. The approximate quantities set forth in the Schedule of Prices/Schedule of Quantities for each Unit Price Item are Owner's estimate only, that Owner reserves the right to increase or decrease such quantities, and that payment for each Unit Price Item shall be made only on the actual number of acceptable units of such Unit Price Item installed complete in place, measured on the basis defined in the Contract;
2. Owner is not subject to state or local sales, use and excise taxes and no such taxes are included in this Schedule of Prices;
3. All other applicable federal, state, and local taxes of every kind and nature applicable to the Work as well as all taxes, contributions, and premiums for unemployment insurance, old age or retirement benefits, pensions, annuities, or other similar benefits are included in this Schedule of Prices; and

4. All costs, royalties, and fees arising from the use on, or the incorporation into, the Work of patented equipment, materials, supplies, tools, appliances, devices, processes, or inventions are included in this Schedule of Prices.

All claim or right to dispute or complain of any such estimated quantity, or to assert that there was any misunderstanding in regard to the nature or amount of any Unit Price Item to be provided or performed, or to claim any additional compensation by reason of the payment of any such tax, contribution, or premium or any such cost, royalty or fee is hereby waived and release.

18. Contract Time Proposal

If this Bidder's Proposal is accepted, Bidder will commence the Work not later than the "Commencement Date" set forth in Part II for the Commodity, and will perform the Work diligently and continuously and will complete the Work not later than the "Completion Date" set forth in Part II. Working hours are defined as being from 7:00 am to 6:00 pm, unless otherwise defined in Part II of the Bid Packet, however OWNER reserves the right to negotiate final work hours.

19. Firm Proposal

All prices and other terms stated in this Bidder's Proposal are firm and shall not be subject to withdrawal, escalation, or change for a period of sixty (60) days after the date on which any Bidder's Proposal is opened or such extended acceptance date for Bidder's Proposals as may be established pursuant to Sections 10 and 13 of the General Instructions to Bidders.

20. Bidder Representations

A. No Collusion. Bidder warrants and represents that the only persons, firms, or corporations interested in this Bidder's Proposal as principals are those named in Bidder's Sworn Acknowledgment attached hereto and that this Bidder's Proposal is made without collusion with any other person, firm or corporation.





If the Illinois Department of Labor revises the prevailing wage rates, the revised prevailing wage rates on the Illinois Department of Labor's website shall apply to this contract and the Contractor will not be allowed additional compensation on account of said revisions. The Contractor shall review the wage rates applicable to the work of the contract at regular intervals in order to ensure the timely payment of current wage rates. 

SPECIAL PROVISIONS**

These Special Provisions supplement the Contract and describe specific requirements singular to the Work under consideration. The following Special Provisions supplement the "Standard Specifications for Road and Bridge Construction", adopted April 1, 2016 or latest addition, (hereinafter referred to as the Standard Specifications) and latest edition of the "Illinois Manual on Uniform Traffic Control Devices for Street and Highways" in effect on the date of invitations for bid. In case of conflict with any part or parts of said specifications, the said Special Provisions shall take precedence and shall govern.

I. AWARD OF CONTRACT

The Contract shall be awarded to the lowest, responsible bidder for performance of the Work as listed in the Schedule of Prices.

The total Contract Price is defined as Bidder's Proposal for making Entire Improvements as in the Schedule of Prices.

II. CONTRACT TIME and START DATE

The sealing compound shall be of rubber-asphalt hot-poured type conforming to ASTM D6690, Type II and Federal Specification SS-S-164. The contractor shall submit the manufacturer's specifications for the hot-poured rubber-asphalt materials at least seven (7) days prior to the start of any work.

Primary transverse and/or longitudinal working cracks shall be routed, cleaned, dried and sealed. Any adjacent secondary cracks shall be only cleaned and sealed. Cracks shall be routed as nearly as possible in a straight line, approximately $\frac{3}{4}$ " wide by $\frac{3}{4}$ " deep as close to a one-to-one ratio as possible. After routing is completed and prior to filling, dust and debris shall be blown from the crack with compressed air and the crack area shall be exposed to a heat lance in order to ensure the crack is completely dry.

A cover material consisting of dry sand approved by the Engineer or his designee shall be applied immediately to the hot-poured rubber-asphalt sealant to minimize tracking by vehicular traffic. The cost of this work shall be considered incidental to the contract. No additional compensation will be paid for application of a cover coating.

Within 48-hours of completion of the roadway crack filling operations, the work areas shall be cleaned of any debris created from the crack routing and crack sealing process at no additional cost. 





Subject: Well No. 12 Preventative Maintenance Update

Issue: On September 19, 2022, the Village Board authorized preventative maintenance for Well No. 12 with our designated deep well contractor, Layne Christensen Company for an amount not-to-exceed \$154,000 from the FY 2022 budget. The maintenance project began on November 14, 2022 and due to unanticipated conditions discovered, additional costs will be incurred in order to complete the project.

Background: After pulling, disassembly and cleaning of the 1130' of 10" column pipe, inspection revealed pitting and corrosion of the interior and exterior column pipe walls and couplings. Reuse of the existing column requires partial replacement and refurbishment. In addition to the unanticipated column pipe condition, the video inspection of the well conducted on November 22, 2022, revealed several large rocks that have dislodged from the open portion of the sandstone formation in the well and are blocking the borehole preventing reinstallation of the pumping assembly and potentially reducing the well capacity.

Analysis: Layne Christensen Company has completed all mechanical repairs to the column pipe, motor and bowl (pump) assembly and has provided a revised cost estimate to include epoxy coating 500' of the existing column pipe in order to extend its service life, adding equipment & crew time to remove the large rocks from the well borehole and to reinstall the column pipe and pumping assembly for an estimated project total of \$194,400 or an overage of \$40,400 to the previously approved amount. Due to the uncertainty of the time necessary to reopen the borehole, staff is recommending adding a \$10,000 contingency for a project total of \$204,400, an overage of \$50,400. The FY2023 budget includes \$130,000 funding for Well 7 scheduled

maintenance that staff is recommending to defer to FY 2024 in order to account for the increase in the cost of the Well 12 maintenance project.

Recommendation: Approve the updated Well No. 12 total project estimate and contingency total of \$204,400, an overage of \$50,400 for Layne Christensen Company to proceed with project completion.

Mr. Schmitt:

The pump equipment at Lake Zurich, IL Well 12 was pulled for scheduled maintenance between November 14-22, 2022. The motor, bowl assembly, column assembly, main cable and attached flat cable were transported to our Aurora yard for further cleaning, disassembly, and inspection. The well was televised on November 29, 2022.

All mechanical repairs have been completed to the column pipe, motor, and bowl assembly as per the recommendations included in the original pump inspection report dated December 14, 2022.

Below is a list of Layne's recommendations and costs to bring the well back into service.

Below discusses in more detail the above cost considerations some additional options and for the Village moving forward.

Column Pipe

We have included the option to apply epoxy coating, inside and out, at \$35.00/Ft. For 500' of column pipe that will be submerged under water to help preserve the equipment installation.

Well Work

There was a significant rock lodged in the well at 1131' that was noted during the downhole television survey. This was not noted during the last service and TV survey in 2017, so it is impossible to tell at one point that was lodged in the hole. Based on our observations, and the known pump setting and water formations, there is a potential for that area to become bridged if not addressed. We recommend running a sand pump downhole to attempt to dislodge the rock and knock it to the bottom of the well to clear hole to the water producing formations. We estimate sixteen (16) hours to complete this. This is very hard to predict and could be more or less depending on progress. The hourly rate is listed below.

Well work; Large Rig and 2-man crew \$498.00/Hr.

We project that we will be in position to remobilize to the site three weeks of the Village's written approval to proceed. However, this schedule will be weather dependent, especially regarding coating of the column pipe.

Layne values its longstanding relationship with the Village of Lake Zurich. We hope that we can be of continued service on this very important project. 







Subject: **Proposed Intergovernmental Agreement – Shared Police Training Simulator**

Issue: The Lake Zurich Police Department has participated in the cooperative purchase and use of a scenario-based decision-making simulator system with five area police departments (Vernon Hills, Mundelein, Libertyville, Lake Forest, & Gurnee) for nearly 20 years. The current system has become outdated and has experienced operational issues that have made it obsolete.

Analysis: The participating agencies initially shared the cost of purchasing a Firearms Training System, Inc. (FATS) use-of-force simulator and utilized that system for approximately 10 years until it aged out of useful service. Approximately 10 years ago, the agencies agreed to share the cost of purchasing a replacement system from MILO Range Simulation Systems.

Each participating department utilizes the mobile training system for two months per year to train their officers. The training simulator utilizes laser-activated weapon systems (pistol, rifle, OC spray, and Taser) that interact with pre-scripted scenarios on a large video screen. The scenarios are designed to put officers in several situations from requiring verbal de-escalation of subjects, to using force - ranging from moderate to deadly. A trained use-of-force instructor operates the system and monitors the trainee to assure they understand Constitutional use-of-force and properly, ethically, and professionally interact with the subjects on screen. Training officers instruct on legal issues of when and how officers can Constitutionally intervene to help emotionally disturbed or suicidal individuals. The topics of ethics and duty to intervene, which is now Illinois law, are also covered. We strive to improve officers' ability to act professionally while maintaining a cool head in tense situations.

At the time of purchase, all agencies agreed to contribute \$500 annually to a joint account maintained by the Village of Vernon Hills to assist with any maintenance costs and to set aside funds for a future purchase when the MILO system was no longer serviceable. The joint account currently holds approximately \$26,000.

The six agencies convened during the first quarter of 2023 and reviewed several use-of-force simulator systems. The group agreed that the Ti Training RECON system provided both the lowest cost and the highest quality of training available. The total cost of the system is \$73,050.

The participating agencies agreed that the group should continue to share in the cost and use of a use-of-force simulator system. Ti Training expressed the desire for a single “owner” of the system for warranty purposes. Based on their current role as fiscal agent, the Village of Vernon Hills agreed to be the named entity on the purchase contract. The participating agencies agreed that funds from the joint account would be put towards the purchase of the new unit.

In 2021, Illinois created a new set of laws under the SAFE-T Act. The law created numerous changes to how a police officer may use force. The changes are complex, and a simulator system with a skilled trainer helps greatly in educating our officers, which keeps the village from suffering potential loss from lawsuits. Additionally, the SAFE-T Act created new training mandates for all officers in order for them to maintain their police officer certification. Much of the training requires “scenario-based use-of-force training” and lists a specified amount of required training hours for all police personnel. All of the training requires a state-certified trainer and a state-certified lesson plan.

The Lake Zurich Police Department has been a leader in this area. Our training sergeant is certified as a trainer with the state of Illinois, and he has certified several other police personnel to train our staff. He has state-certified lesson plans that utilize the use-of-force simulator system to provide mandated “scenario-based use-of-force” training required by statute.

It should be noted that other state-certified training is scarce, and is usually held at sites away from Lake Zurich. Even when available, these trainings cost the village in overtime wage expense to pay for travel and time, and also to pay for shift-coverage when the officer is away from their usual job assignment. Training in-house with the shared use-of-force training simulator is done when the officer is on-duty, and does not cost additional wage expense.

The requested Intergovernmental Agreement is consistent with the goals and objectives of the village’s strategic plan including fiscal sustainability (continue organizational analysis to increase efficiencies), and service sustainability (develop a high-performance organization).

Recommendation: In order to provide the state-required training to our officers, the Lake Zurich Police Department respectfully requests approval of the attached Intergovernmental Agreement relating to the participation in the shared purchase of a Ti Training RECON system at a one-time cost of \$7,025 along with a \$1,500 annual maintenance fee. These are budgeted funds.

**INTERGOVERNMENTAL COOPERATION AGREEMENT
FOR THE PURPOSE OF A SHARED TRAINING SIMULATOR
BETWEEN THE VILLAGE OF VERNON HILLS
AND LOCAL LAW ENFORCEMENT PARTNERS**

This Agreement is entered into as of May 1st, 2023 (the "Effective Date"), by and between the VILLAGE OF VERNON HILLS, the VILLAGE OF MUNDELEIN, the VILLAGE OF LIBERTYVILLE, the CITY OF LAKE FOREST, the VILLAGE OF LAKE ZURICH, and the VILLAGE OF GURNEE (collectively referred to as "Party or Parties" and "Agency").

WHEREAS, Section 10 of Article VII of the Illinois Constitution of 1970 and the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/1 et seq. enables the Parties here to enter into agreements among themselves and provides authority for intergovernmental cooperation; and

WHEREAS the Parties find it to be in the best interest of the Police Departments of the Village of Vernon Hills, the Village of Mundelein, the Village of Libertyville, the City of Lake Forest, the Village of Lake Zurich, and the Village of Gurnee to share resources in order to improve the training available to each department's police officers; and

WHEREAS, the Parties for the past twenty years have shared the cost of a scenario based decision making simulator and are now seeking to memorialize this continued arrangement; and

WHEREAS, to train police officers in an effective and cost-efficient manner, the Parties desire to share the cost of purchasing a new portable scenario based decision making simulator manufactured by Ti Training LE LLC ; and,

NOW, THEREFORE, the Parties agree as follows:

1. **Simulator Model:** The Parties agree to purchase a X SIMULATOR from Ti Training LE LLC shown on EXHIBIT A attached hereto and incorporated herein.
2. **Financial Responsibilities:** The Parties agree to contribute \$1,500 per year on or before June 1st of each year to an account held by the Village of Vernon Hills ("Joint Account") beginning in FY24/25 and continuing on a yearly basis to fund mutually agreeable future training components/opportunities. It will cost \$51,150 to fund the base price of the simulator, \$16,000 to fund the warranty, and \$5900 to fund the requisite kits. The total cost of the project being \$73,050. The current balance of the Joint Account is \$26,104.90 which amount shall be retained in the account and put towards the acquisition of the new simulator.
3. **Schedule Governing Use:** Each Agency shall have access to the simulator for two months out of every calendar year pursuant to the currently existing Schedule. The Schedule may be revisited every May and any change to the schedule shall be agreed upon by a 2/3 vote of the Parties to this Agreement. The Parties will have the option to agree to a one-time change in rotation should any hardship be experienced by the departments.
4. **Dispute Resolution:** If any Agency damages the simulator, the repair costs will come out of the communal fund. However, if any Agency should damage the handgun recoil kits which are shared by specific departments, then it shall be the responsibility of that Agency to fund the repair.
5. **Termination:** Each Agency shall have the ability to terminate its participation in this Agreement upon 30 days' written notice to the Parties. The terminating Agency will be able to reclaim only the funds that they have contributed to the fund on a prorated basis. If any Agency falls delinquent in their payment to the fund, it will have 90 days to submit payment. If the Agency does not make the payment within 90 days, it will forfeit its use of the simulator until the payment is made. Should any Agency not pay their portion for two years, it will be removed from the Agreement and will be refunded any unused portion of their contribution.
6. **Removal:** An Agency may only be removed for cause. In order to remove an Agency, there must be a 2/3 vote of the Parties and upon removal, the Agency shall not be entitled to any unused funds contributed to the fund.

7. **Changes and Amendments:** Any mutually agreed upon changes shall be effective when incorporated in written amendments to this Agreement. The Party desiring the revision shall request amendments to the terms and conditions of this Agreement in writing. Any adjustment to this Agreement shall be effective only upon the mutual agreement in writing of all of the Parties to the Agreement. No verbal agreements or conversations prior to execution of this Agreement or any requested Amendment shall affect or modify any of the terms or conditions of this Agreement.

8. **Execution.** This Agreement may be executed in one or more counterparts, which together shall constitute one and the same instrument.

Subject: Bid Award: 2023 Road Program

Issue: The FY 2023 budget includes \$3.2 Million in the Motor Fuel Tax (MFT) for the annual road resurfacing project. A portion of the funding includes grant proceeds allocated through the Rebuild Illinois Program (RBI).

Village Strategic Plan: This agenda item is consistent with the following Goals and Objectives of the Strategic Plan.

- **Infrastructure Investment:** Develop and formalize a long-range street maintenance program.

Background: On June 28, 2019 Governor Pritzker signed the Rebuild Illinois Capital Plan to fund transportation projects and improvements, along with many other investments. Funded through the Motor Fuel Tax Program (MFT), the proceeds have been designated specifically for transportation improvement projects with an average useful life of greater than or equal to 13 years.

The Village of Lake Zurich has received \$1,293,760.00 in grant funds through the Rebuild Illinois Bond Program (RBI) from the State of Illinois. As the grant proceeds are designated specifically for transportation improvement projects, the funds will be allocated to the Village's annual Road Resurfacing Program for 2023.

In 2019 the Village's Pavement Management and Five-Year Road Resurfacing Capital Plan was updated through a collaborative effort between Public Works and Manhard Consulting. Year 4 (2023) of the program consists of the Eastern portion of the Old Mill Grove Subdivision, including Old Mill Grove Road in its entirety. In addition, the following roads on the East Side of the Old Mill Grove subdivision will be included in the 2023 program. Brush Hill, Browning Lane, Millbrook Drive, Kingwood Lane, Heartwood Lane, Pebble Creek Drive, and Ridgewood Court.

The scope of work includes pavement resurfacing, concrete repair, utility infrastructure repair, and other related items. Upon completion of the proposed improvements, the roads should have an estimated service life of 15-20 years with proper maintenance (crack sealing, spot repairs, etc.).

Analysis: Staff solicited bids for the 2023 Road Program in March. The bid opening occurred on April 14, 2023. The Village received five (5) bids. The bid results are shown below. The lowest responsible bid was received from Arrow Road Construction Co., Elk Grove Village, Illinois. As Arrow Road has completed previous road programs within the Village of Lake Zurich, Staff is familiar with Arrow Road Construction Co. and would recommend their services.


