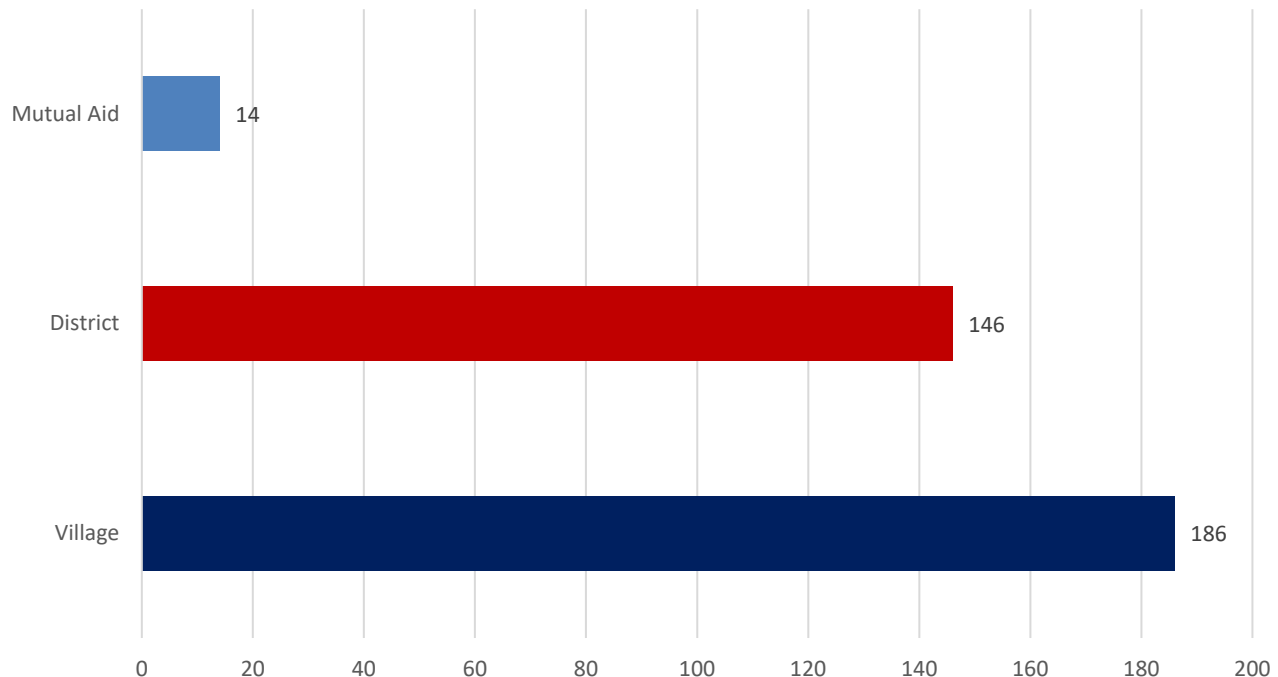

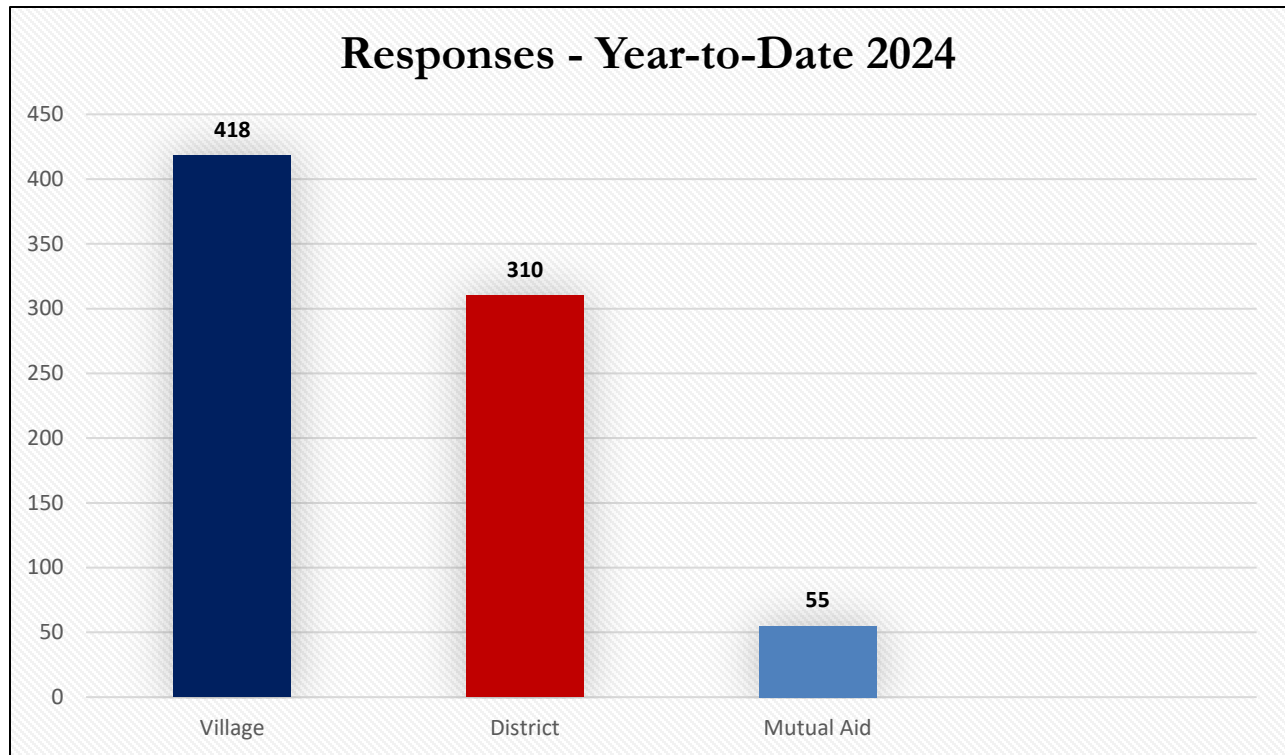

Responses - Year-to-Date 2024



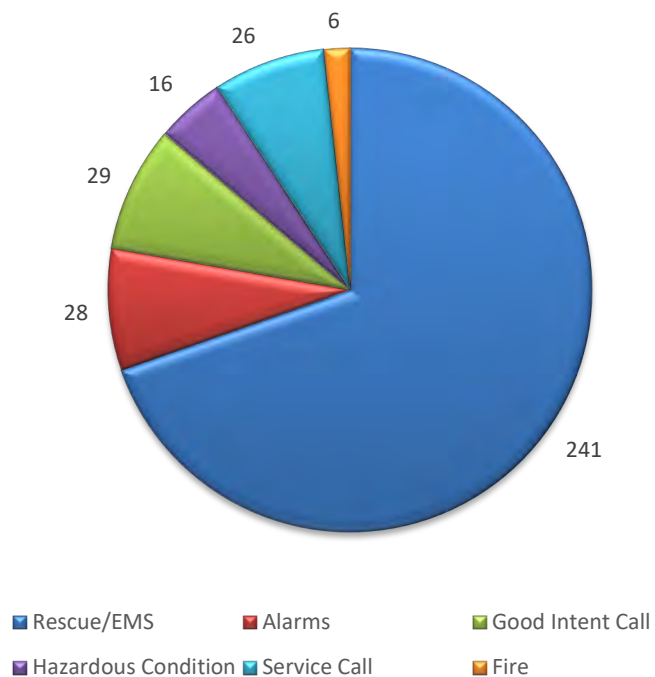
Incident Types

The Department codes all incidents within the National Fire Incident Reporting System (NFIRS).

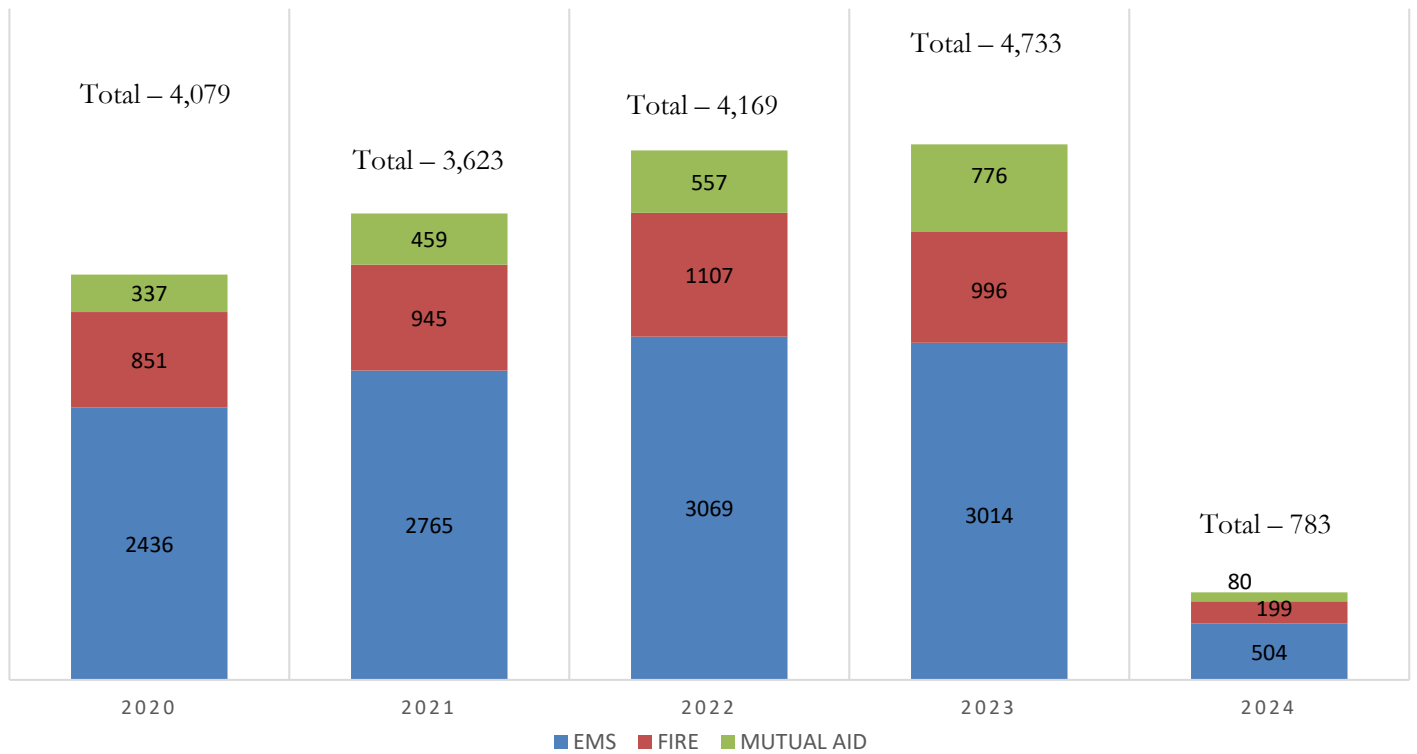
The codes all relate to the text categories noted in the chart to the right. Rescue and EMS incidents account for the majority of incidents we respond to.

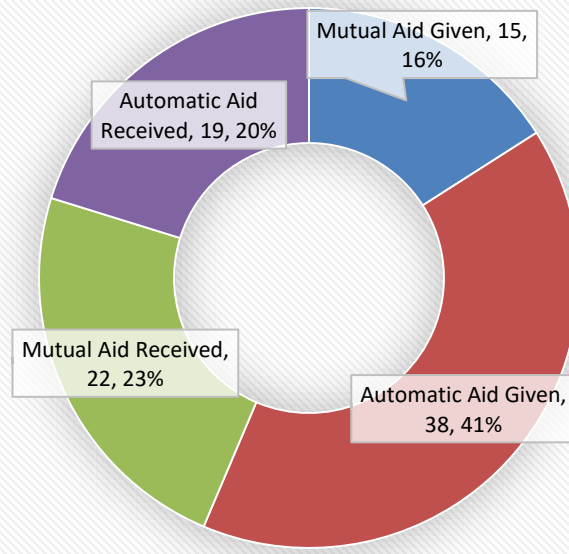

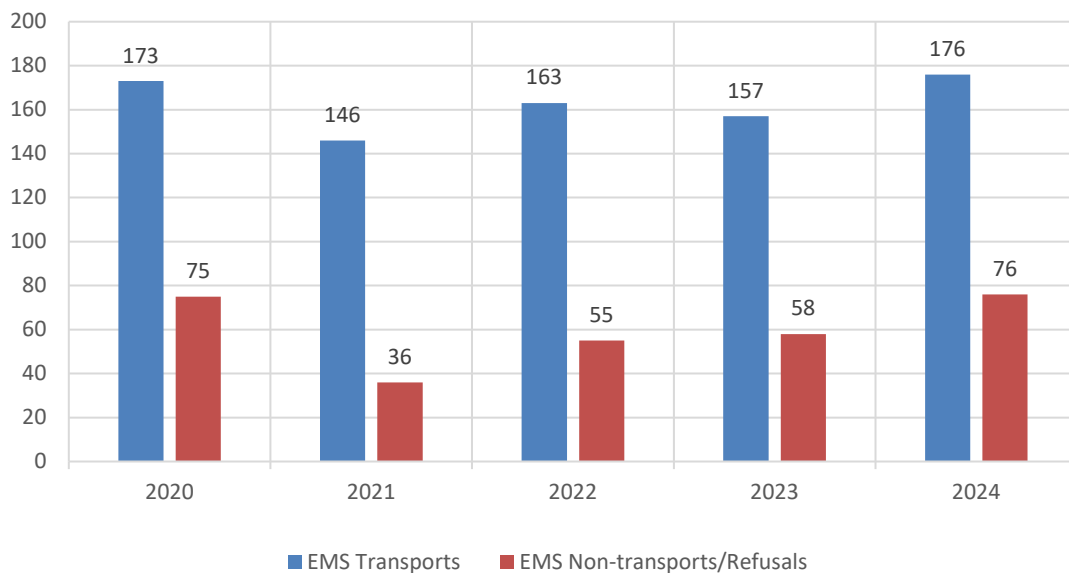

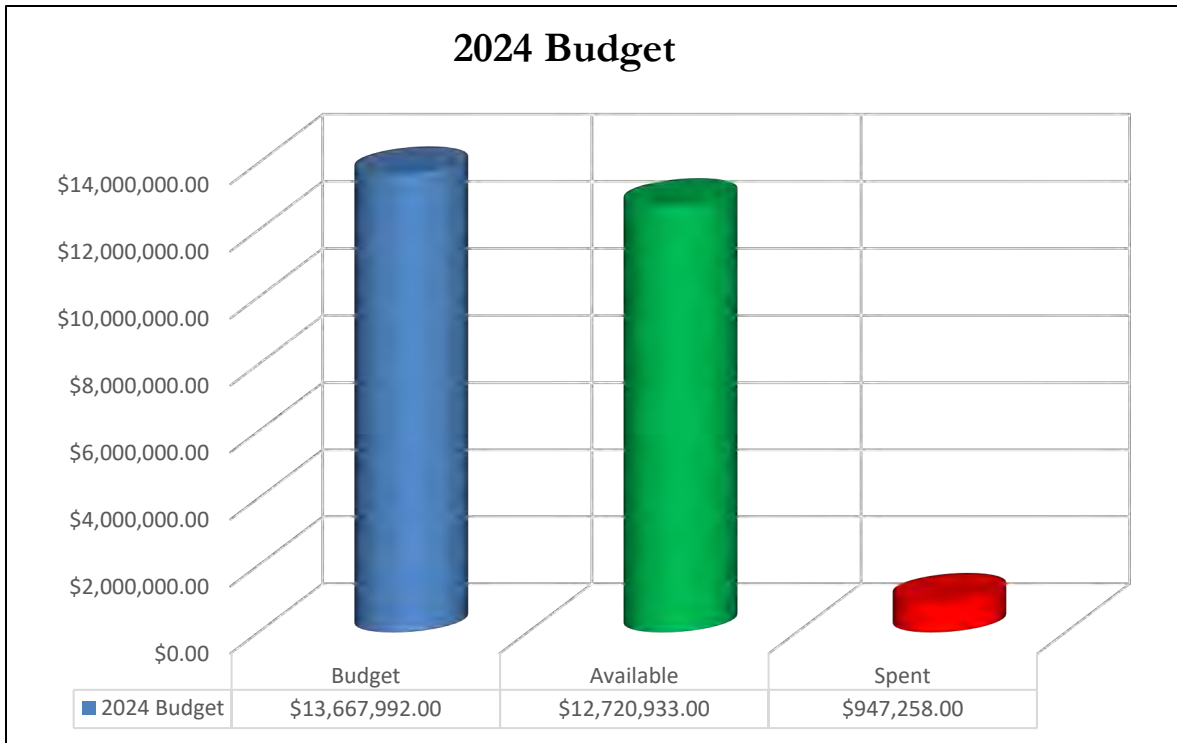


EMS Incidents

The chart shown below reflects EMS Transports vs. Non-Transports/Refusals. It's important to note that not every EMS call will result in a transport to the hospital. However, as you'll see from the data, transports always outpace Non-Transports/Refusals. This chart below compares the month of February across 5 years.

On February 26, all four ambulances received new Stryker Power-Pro 2 ambulance cots, marking the completion of phase one in our new equipment agreement with Stryker. These upgraded stretchers bring several safety enhancements compared to their predecessors. Key features include a redesigned foot section that extends and retracts an extra three inches, which will allow for navigation through tighter quarters. The new transport handle also allows for patient movement at a lower, safer height. A new integrated lighting system and reflectors will provide additional visibility during nighttime operations. Bumper detection technology will minimize the risk of cot damage and potential injuries to both paramedics and patients during patient loading and unloading. The stretchers are also equipped with an integrated steering and wheel lock system, coupled with an upgraded hydraulics system capable of safely lifting up to 700 lbs. This delivery marks the initial phase of our comprehensive equipment upgrade plan with Stryker, with two additional phases for Lucas CPR devices and updated LifePak cardiac monitors planned for delivery shortly. These advancements underscore our continued commitment to enhance patient care and safety.

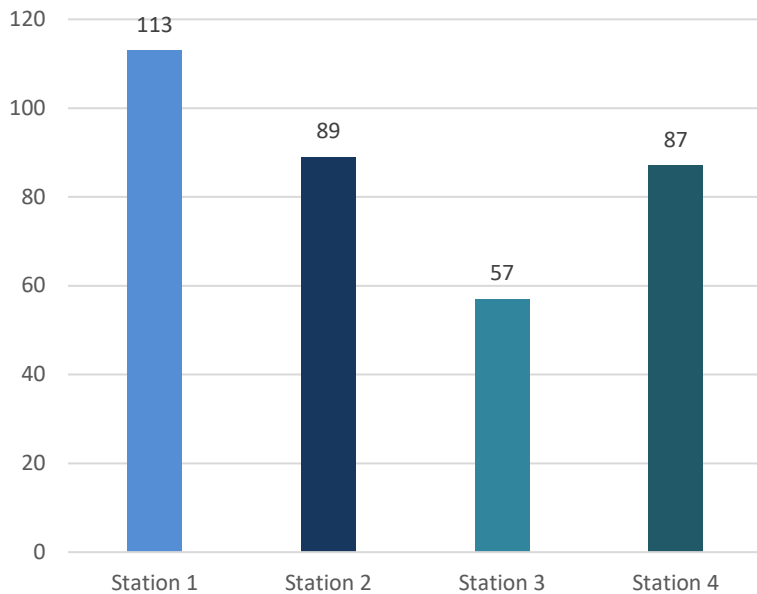

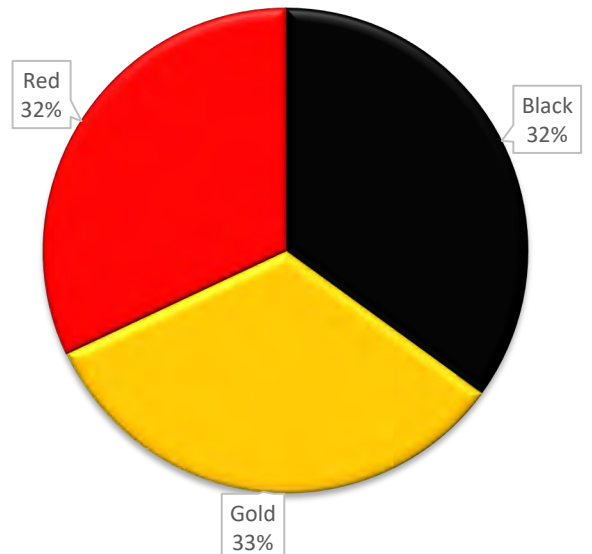

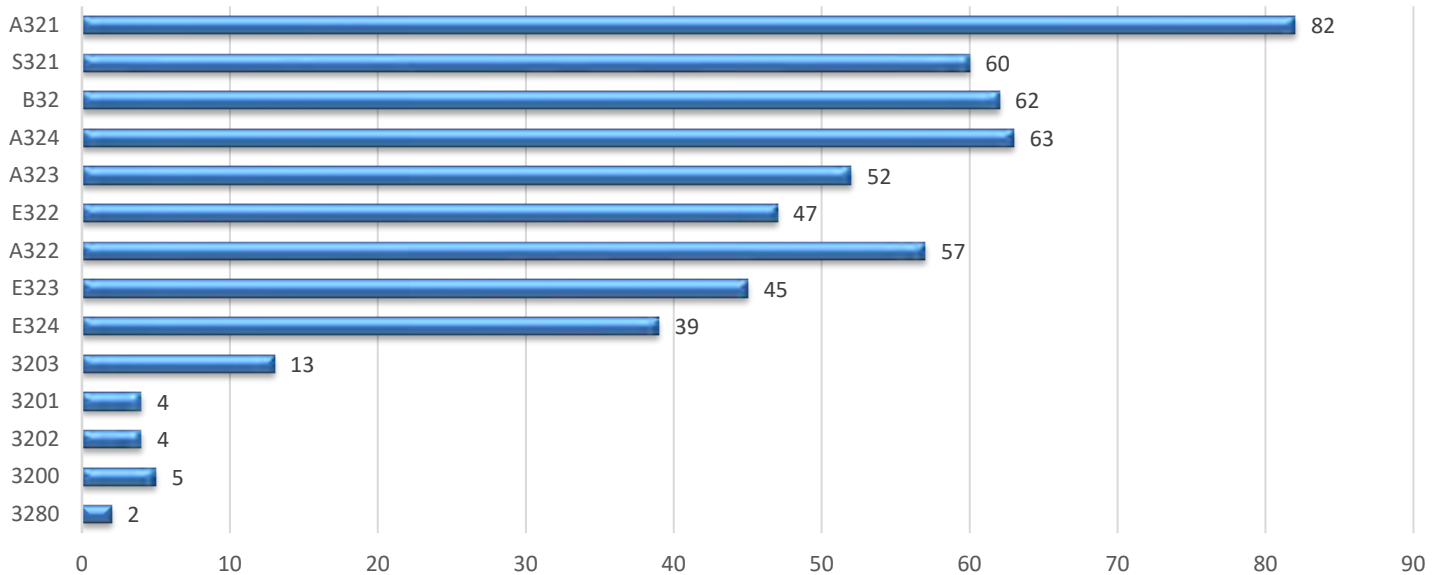
Incident Count by Station



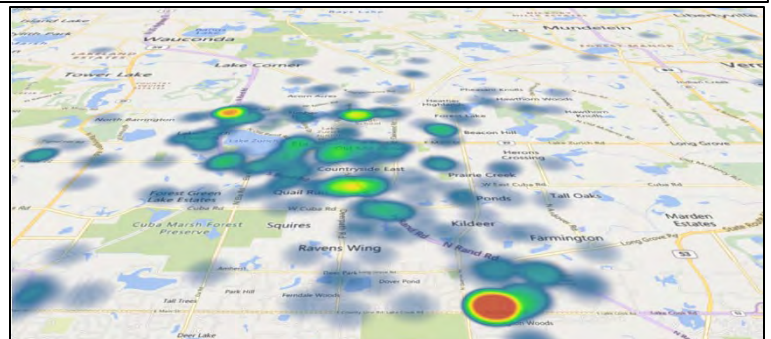
Incident Percentage by Shift



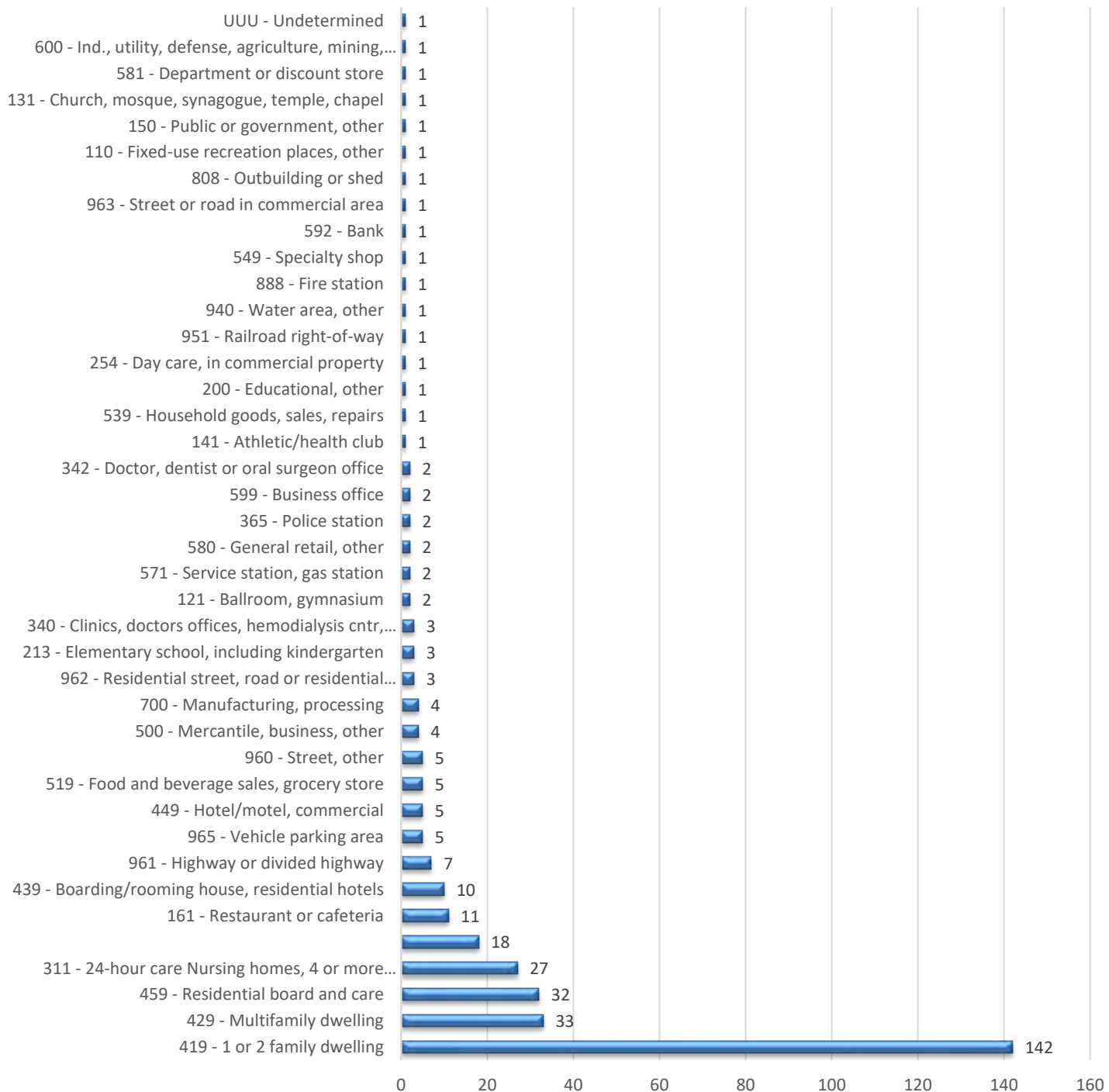
Incident Count by Unit



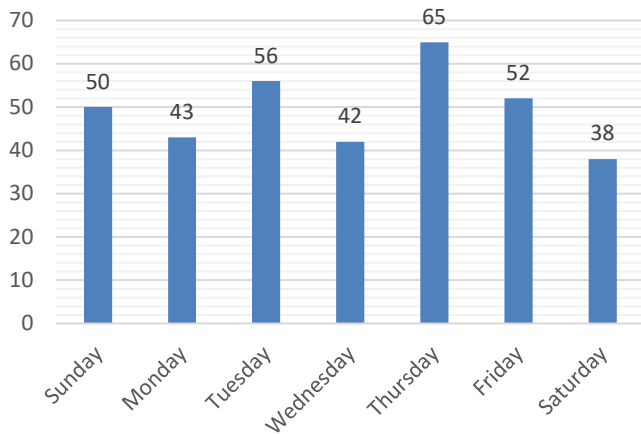
Response Locations The graphic to the right is a visual representation of call distribution for February. As visually displayed, the assisted living/memory care facilities are a large portion of our department calls and are consistently within the top locations responded to each month. We frequently respond to doctor offices, health clinics, and automobile accidents near the Route 12 corridor.



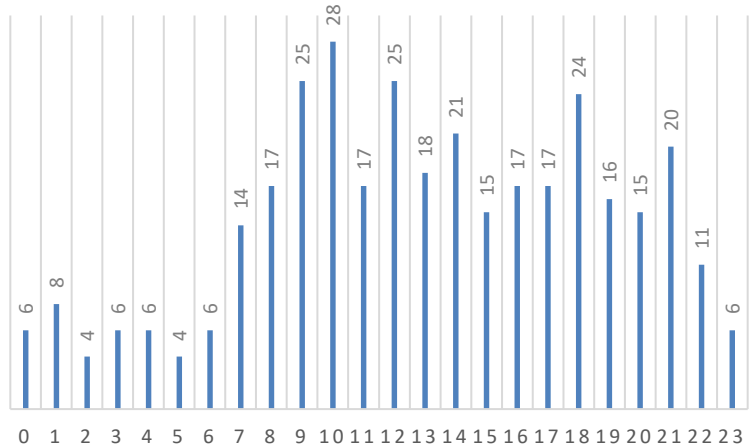
Incidents by Property Type - February 2024

Response Times

Response time includes three key factors: **dispatch handling, turnout, and travel time.**

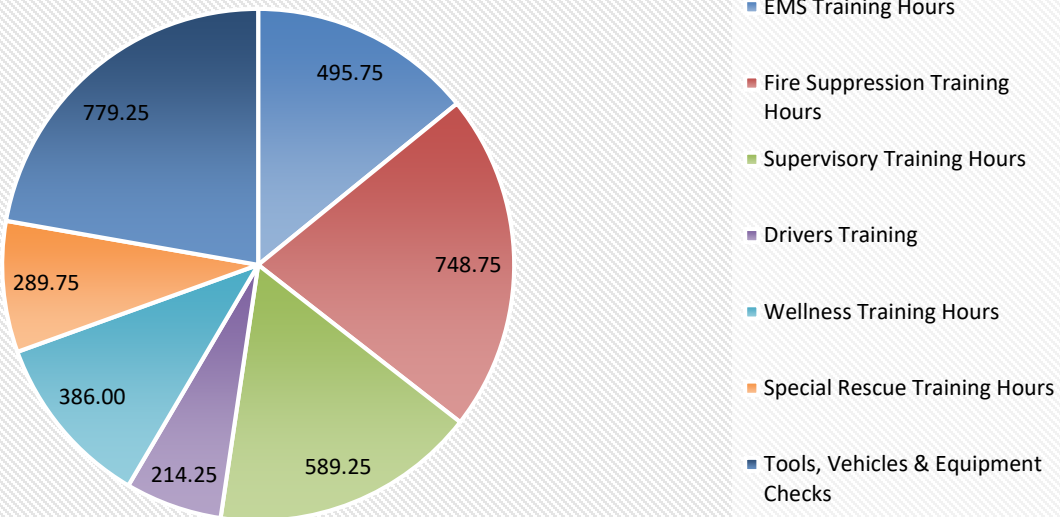
Dispatch handling time is when dispatch takes in information and then dispatch personnel. The turnout time is when the crews receive the call to the time they get into the vehicles and hit the enroute button. Travel time reflects the time from en route to when they arrive at the incident scene. Construction, speed limits, weather, and train traffic can impact response times. The overall goal for arrival at an emergency fire call is 6 minutes and 20 seconds from the time of notification until the first unit arrives on the scene. For a response to an EMS incident, this time is 6 minutes.

The following shows the average times for all emergent/non-emergent incidents, with arrival on scene for EMS, Fire, and Mutual Aid in February 2024.
