1. CALL TO ORDER at 7.00pm by Chairperson Orlando Stratman

Chairperson Stratman welcomed Planner Ms. McCauley and Dir. Saher introduced her to the Commission.

Application PZC 2024-02 for a Planned Unit Development at 880 South Rand Road, was made by Commissioner Schultz, seconded by Commissioner Marx.

A. 60 South Old Rand Road – Special Use Permit (2024-03):

Application for a Special Use Permit to allow for massage therapy services at the property located within the B-2 Central Business District, and the DR Downtown Redevelopment Overlay District.

Applicant: Dorothy Deemer, d/b/a Kneading Works Massage Therapy LLC

Owner: Dr. Steven A. Landman

Chairperson Stratman asked the Staff to confirm that proper notice was provided of this item and Dir. affirmed that it was.

Ms. Deemer gave a PowerPoint presentation on her proposal for the property at 60 S. Old Rand Road. Chair Stratman asked for comments from the commissioners and there were none.

Application for a Special Use Permit for a Planned Unit Development (PUD) to allow for the development of a drive-through coffee shop at the property located within the B-3 Regional Shopping District.

Applicant: Who Brew IL 1, LLC

Owner: MJR Lake Zurich Real Estate Holding Company, LLC

Dir. Saher confirmed that proper notice was provided of this item and then he introduced Chris George and Ricky Silverman. Mr. George gave a PowerPoint presentation of their proposal as he described the background of the company. Chair Stratman requested information on the monument sign from staff and Dir. Saher explained the Village code and the petitioners will work with staff to conform to regulations.

Discussion followed on traffic on the frontage road and traffic patterns and complying with the staff's concerns.

PUBLIC TESTIMONY.

Resident Kathy Lohrstorfer, 415 Pheasant Ridge Road, was sworn in by Chairperson Stratman. Ms. Lohrstorfer had concerns about noise and possible tree removal.

Commissioner Marx expressed his concerns about this proposal conforming to the future comprehensive plan. Dir. Saher gave an explanation.

Discussion followed on traffic patterns around Pheasant Ridge Road and the frontage roads to Walmart and to this property


