**1. CALL TO ORDER AND ROLL CALL**

The meeting was called to order by Sean Gallagher at 6:31 PM.

**2. Official Oath: Sean Gallagher, Corey Frank, Roger Sugrue**

Oaths postponed to next meeting.

**3. APPROVAL OF MINUTES – June 15, 2022**

MOTION to approve the meeting minutes of June 15, 2022 made by Colin Gaffney, seconded by Corey Frank.

Voice votes: No objection. MOTION CARRIED

**4. OLD BUSINESS**

- None

**5. NEW BUSINESS**

- **North Old Rand Road Traffic Counts**
- Sergeant Gaffney reminded members that a citizen requested a raising of the speed limit on North Old Rand Road in 2017. Multiple speed studies were conducted and CPAC made a recommendation to raise the speed limit on North Old Rand Road to 30 MPH at the September 13, 2017 meeting.
- Sergeant Gaffney and Director Brown said at that time, concerns were raised over the impact that Lifetime Fitness would have on traffic counts.
- Sergeant Gaffney had the Lake Zurich Police Department's Traffic Safety Division conduct traffic studies in spring of 2023 on North Old Rand west of Pine Tree Row, as well as in the 500 block of North Old Rand Road, to compare them to numbers gathered as part of the 2017 studies.
- The Illinois Department of Transportation's data indicates an Annual Average Daily Traffic (AADT) count of 4,200 vehicles on North Old Rand Road.
- Sergeant Gaffney shared the results of the studies: A 2017 study near the 500 block of North Old Rand Road revealed an AADT of 4,741. The 2023 study revealed an AADT of 4,730, representing a .03% decrease. In 2017, no data was collected for North Old Rand west of Pine Tree Row, but a 2023 study of that stretch revealed an AADT of 3,395 vehicles.

- Director Brown noted that since Lifetime has now been open for some time, the studies show that there has not been an increase in traffic count on North Old Rand Road since 2017.
- Chairperson Gallagher and Member Frank stated that in their regular travels on North Old Rand Road, they don't believe there is any more traffic than in years past.
- Chairperson Gallagher said he believes there is more traffic near downtown due to the park, Sunset Pavilion, and downtown shops and restaurants, rather than Lifetime Fitness.
- Director Brown mentioned that Lifetime Fitness was targeting members from not only Lake Zurich, but surrounding communities, which likely means many members are entering and exiting onto Route 12.

MOTION to make no further recommendations regarding traffic related to Lifetime Fitness was made by Laurie Stutzman, seconded by Sean Gallagher.

Voice votes: No objection. MOTION CARRIED
