1025 OLD MCHENRY ROAD – TO CONSIDER A ZONING CODE TEXT AMENDMENT AND A SPECIAL USE PERMIT FOR EVER WELL THERAPEUTIC MASSAGE SERVICES, INC., ON THE SUBJECT PROPERTY ZONED IN THE VILLAGE’S IB INSTITUTIONAL BUILDINGS DISTRICT – PETITIONER LINDA CLIFFORD, PRESIDENT AND OWNER

The public hearing was opened at 7:34 p.m. The court reporter swore in those testifying.

Sean Nelson, Executive Director of The Foglia YMCA, 1025 Old McHenry Road, presented their request to be permitted to provide massage therapy as a service to their members and the community. The YMCA would lease space to Linda Clifford, president of Ever Well Therapeutic Massage Services, Inc., who is a co-applicant.

Commissioner Jackson arrived at 7:39 p.m.

Ms. Clifford provided information about her qualifications and her existing massage therapy business in Barrington. She would like to provide massage during the hours that the YMCA is open because some of the members prefer to receive early morning or late evening massages. Ms. Clifford is the sole employee, but she may consider hiring a part-time licensed massage therapist in the future if the demand warrants it.

In his memorandum dated January 2, 2009, Village Planner Gadde provided an excerpt from Sections 4-102 (E) 23 and 5-102 (E) 35 of the Zoning Code, which permit certain Miscellaneous Personal Services, Not Elsewhere Classified (7299), under which massage therapy subject to certain conditions as a guideline for the Plan Commission to base their motion upon if they approved the petition.

The public hearing was closed at 7:46 p.m.

Discussion followed on applying the proper verbiage for massage therapy in the Village's IB District and the hours that massage would be permitted. It was agreed that the services should be allowed during the hours of operation for the YMCA so Ms. Clifford and her clients would not be needlessly hampered. The hours that massage is permitted should be tied to the principal business hours for any future applicants in the IB District.

MOTION made by Commissioner Crane, seconded by Commissioner Minden, to recommend the Board of Trustees approve a Zoning Code text amendment to permit massage therapy as a permitted special use in the Village's IB District as an ancillary use for civic, social, and fraternal organizations including the YMCA provided the use shall be permitted during normal business hours for the permitted business seven days a week and such services shall be performed only by trained therapists professionally certified by the Illinois Department of Financial and Professional Regulation.
