1. CALL TO ORDER AND ROLL CALL

The meeting was called to order by Chairperson Scott Garrison at 7 PM

Present were Chairman Garrison, Members Tony Harper, Mary Kozub, and Shawn Walkington.

2. PUBLIC COMMENT - There was no public comment

5. ARBOR DAY – Commissioner Walkington is going to contact Mark Cook's Nursery about the availability for trees to plant for Arbor Day. The Tree Commission would like to get an Oak Tree as the "Memorial Tree" in remembrance for Al Froehde.

6. Tree Commission Member Appointment - Commissioner Garrison had a copy of the Park and Recreation Board Member application. The Commission will use that as a draft for our application. Commissioner Kozub put together a job description for tree commission applicants. The Commission agrees with the job description but with minor changes.

7. New Business -

Plan Review - New Life Lutheran Church – The Plan was rejected. There is not enough diversity in their shade tree plantings. The number of trees planted is five; they need to add a couple more species of trees like Oak and Hickory. The Commission would also like to see White Pines instead of Norway Spruce.

Memorial Plaque – The Tree Commissioner discussed getting a plaque to put by the memorial tree to be planted for Al Froehde. The Commission discussed wording for the plaque and Commissioner Garrison will solicit quotes for the plaque and stone.

Meeting Change – Commissioner Walkington will not be able to attend the next meeting. The Commissioner members agreed to change the meeting to the following week, April 13, 2010.
