1. CALL TO ORDER AND ROLL CALL

The meeting was called to order by Chairperson Jim Schultz at 7:00 PM

2. APPROVAL OF MINUTES, June 9, 2010

A. Stop sign-Old Mill Grove Road @ Brittany Road

The matter was taken off of the agenda due to no residents appearing to discuss the matter for the last two meetings. Sergeant T. Goodyear advised the Traffic Safety Unit would conduct a traffic study to determine the need for any additional changes to the area.

5. New Business

A. Traffic Issues (Concorde Village) The following residents attended the meeting on behalf of Concorde Village: Robert and Jaki Harding, Jennifer Eng, Nicole Spatia-Wyatt, Aleksandar Zigic, Thano and Annamarie Koulourianos, Ted and Donna Mawrkiewicz, David Williams, Ken Skord and Cindy Westerman.

At the June 9, 2010 meeting the residents indicated the following problems along June Terrace:

- Excessive traffic volume
- Excessive speed
- Blind corner on June Terrace at Rosehall Drive
- Sidewalks not extended to COSTCO
- Association would like business owners to seal coat the bike path
- Poor numbering system for Concorde Village
- Traffic sign missing from median of Rte. 22 / June Terrace

The following solutions were discussed:

- *Crosswalks at one or both Rosehall intersections
- * Review signage
- * Extension of sidewalk to COSTCO
- * Stripe the roadway
- * Review bus stops with District 95

The Traffic Safety Unit conducted a traffic study; however, the residents felt the study should be conducted during the month of September due to the increase in traffic during that time period. Sergeant T. Goodyear advised she needed to consult with Commander D. Bradstreet regarding the study prior to making a recommendation. A complete study and analysis with a recommendation be completed by the October 13, 2010 meeting so a recommendation can be forwarded to the safety committee.

Mike Brown will be installing two signs on June Terrace for “Slow – Children Playing”, one facing each direction.
