5. New Business
 - A. External Special Events Request- Jack O'Lantern World
Summary: Staff is seeking a Park and Recreation Advisory Board recommendation for the Jack O'Lantern World special event proposed to be held at Paulus Park Friday-Sunday throughout the month of October (portion of the South end of the property closed off during entire month of October, week of set up the last week in September and a week clean up the first week in November). Entry to this ticketed event includes a ½ mile walk through the park to view family friendly jack-o-lantern scenes. Event proposal also includes use of the restrooms, electric, food trucks and alcohol sales.
 - B. External Special Events Request- Bushel of Apples Fall Fest
Summary: Staff is seeking a Park and Recreation Advisory Board recommendation for the Bushel of Apples Fall Fest special event proposed to be held at Paulus Park Saturday, October 2 (11am-9pm if able to work with All Community Events pending their event approvals) and Sunday, October 3 (11am-6pm). Event proposal also includes use of restrooms, electric, food trucks, draft beer and packaged beer to go sales as well as family friendly activities.

 - A. Playground Renovation Plan
During a recent inspection of the playground equipment at Jonquil Park, Public Works staff noted safety concerns that warranted closing the playground at Jonquil Park. The playground, featuring a play structure and swing set, was built in 1994 and is the oldest maintained by the Village. Per the Playground Renovation Plan, developed in 2016 to guide future park equipment renovations, recommended that the Jonquil Park playground be removed and not replaced at the end of the equipment's useful life. At the Monday, May 3rd Village Board meeting, Staff provided the Village Board additional information and options for this playground at the Monday, May 3rd Village Board

meeting. Village Board provided direction make the necessary repairs and revisit the plan to include both Jonquil and Warwick Parks.
