



Responses - Year-to-Date 2023




Incident Types

The Department codes all incidents within the National Fire Incident Reporting System (NFIRS).


The codes all relate to the text categories noted in the chart to the right. Rescue and EMS incidents account for the majority of incidents we respond to.






I write to let you know that you and your crew are phenomenal. You have no idea how appreciative I am of the manner in which you assisted me in my time of need on Monday, June 26, 2023 at approximately 9:30 AM. I was having an extreme exacerbation-not my first, but the second since I moved to the area in March. I could not breath after I had gone to breakfast, to the front desk and back upstairs. I knew I needed the ambulance. Having been a AGSH in May, I knew I needed the hospital but just could not drive.

Within minutes the crew was here. I was pretty panicked when you arrived. You introduced yourself and crew. You kept doing your job but also, kept talking WITH me, not at me. You told me how you knew me-through my son Nathan that you were friends with in high school and still are. You asked about family, relayed stories, kept working, and just worked to ease my panic. What I found so profound was you, and the crew, were taking into account my state of mind. You worked with me, not against me. Something not every EMT understands.

Once in the ambulance, you instructed the crew to take the back roads; both for ease of transport and to avoid traffic as you explained to me. This was as essential as it is directly intertwined with the overall care.

At the hospital, you made sure I was settled in, came and checked on me before you left and said good bye and good luck. Such a thoughtful gesture. You, and the crew, are shining example of how an EMT squad should function. You all deserve special recognition. As such, I intend to write the Director of the Lake Zurich Fire/EMT Department and recommend all of you for commendation. I am eternally grateful to each of you.

Community Relations / Public Education






Incident Count by Station

Incident Count by Unit




Response Locations


The graphic to the right is a visual representation of call distribution for July.

As visually displayed, the assisted living/memory care facilities are a large portion of our department calls and are consistently within the top locations responded to each month.

We frequently respond to doctor offices, health clinics, and automobile accidents near the Route 12 corridor.





Incidents by Property Type - July 2023

Response Times

Response time includes three key factors: **dispatch handling, turnout, and travel time**.

Dispatch handling time is when dispatch takes in information and then dispatch personnel. The turnout time is when the crews receive the call to the time they get into the vehicles and hit the enroute button. Travel time reflects the time from en route to when they arrive at the incident scene. Construction, speed limits, weather, and train traffic can impact response times. The overall goal for arrival at an emergency fire call is 6 minutes and 20 seconds from the time of notification until the first unit arrives on the scene. For a response to an EMS incident, this time is 6 minutes.

The following shows the average times for all incidents including EMS, Fire, and Mutual Aid in July 2023.


