Sprinkler, Fire Alarm, and Other Suppression Systems

## What to Submit

- \*Completed Fire Systems Permit application.
- \*Completed fee calculation section on this form.
- \*Two (2) complete sets of plans along with a PDF of the plans sent to **fire.bureau.org** for record keeping.
- \*Plans shall include:
  - \*Completed Fire Systems Permit Application
  - \*Two (2) sets of cut sheets and/or calculations.
  - \*Current Contractor License.

## Permit Process

\*All permits for sprinkler (commercial, single-family, multi-family) fire alarm and other suppression systems will be issued at Fire Station #3 at 1075 Old McHenry Rd, Lake Zurich, IL 60047.

\*Applications will be subject to a review fee and a permit fee.

## Fees

**Commercial & Multi-Family Sprinklers**  
\$260.00 + \$11 per head

**Single Family Sprinklers**  
\$225.00 flat fee

**Fire Alarm Systems**  
\$340.00 + \$11 per initiating and signaling device

**Other Fire Suppression System**  
\$350.00 flat fee

## Note:

\*Upon review of the plans, you will be notified to pick up your permit. All required fees must be paid prior to issuance of the permit. Sprinkler or Alarm work started prior to issuance of permit will be subject to penalties according to the Village of Lake Zurich Municipal Code Section 8-1-22.

**NO PERMITS WILL BE ISSUED UNTIL A BUILDING PERMIT HAS BEEN ISSUED AND CONFIRMED BY THE BUILDING DEPARTMENT.**
