- The sale is held outdoors so dress for the weather.
- The market is held rain or shine, however, in the case of severe weather, we would make a determination on Friday at approximately 12pm regarding market status so please make sure to check your email if the weather turns on us.
- All items sold must be related to children and documented on your application that was submitted.
- Must follow all rules of sale and bring/set up your own table, chairs, tent (if desired but must have weights to hold it down- note, no stakes), etc.
- Space allocated per area is approximately 10x10 so please plan accordingly with your items, equipment, etc. For set up purposes, you will not be able to pull right up to your area, so you will need to carry the materials or bring a cart/dolly. We recommend tagging the items with prices or having a price listing. Also make sure that you cash to make change based on your pricing.
- There MUST be one adult per table with the youth the entire time of the market for assistance and supervision.
- The Kids Yard Sale section of the market will be right outside of the Paulus Park Barn entrance (where restrooms are located)
- Spots will be first come first serve; please see attached layout. (Please note; being closer to the Barn we have over 80 kids in camp leaving for the day from 3-6pm and they are your target market!).
- Set up is between the hours of 1-2:45pm with the market hours of 3-7pm. Please go into the Barn to see Marisa Boynton, Jenna Stanonik or Jan Poynton upon arriving at the market for check-in. If you should need to reach us the day of, please contact the Barn's main number 847-438-5146 and speak to our guest service associate.
- Please enter Paulus Park the back way down Whitney Road as your section is closer to the Barn not the main entrance. This will help with unloading and loading which can be done near your booth area (cars then need to be parked in the parking lot no later than 2:45pm until the end of the market). (Turn from Rt. 12 to 22nd, make a left onto Whitney Road and follow it into the Paulus Park Barn parking lot).
