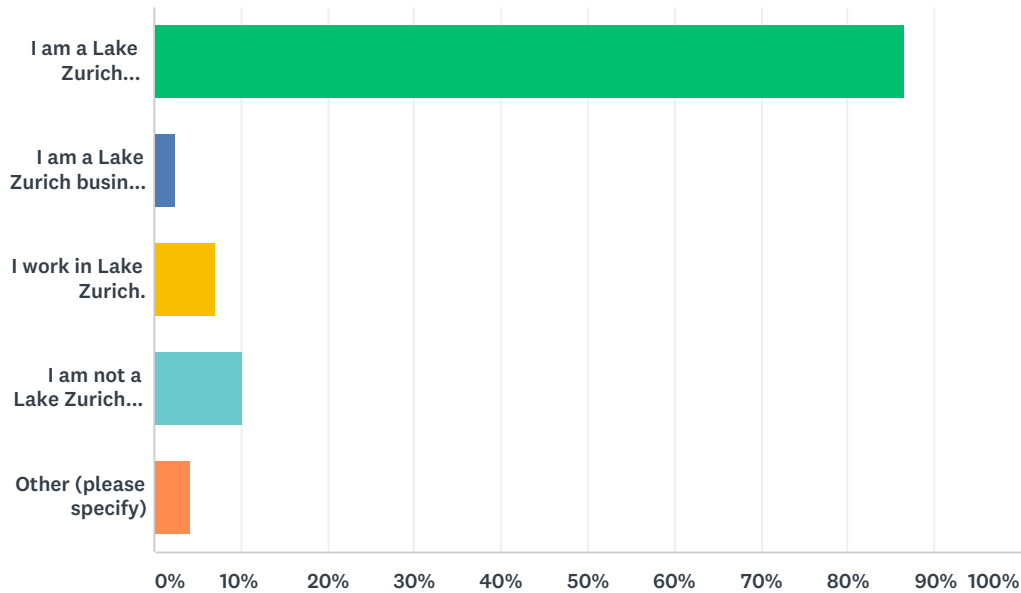


Q1 Which of the following best describes you? (Check all that apply)

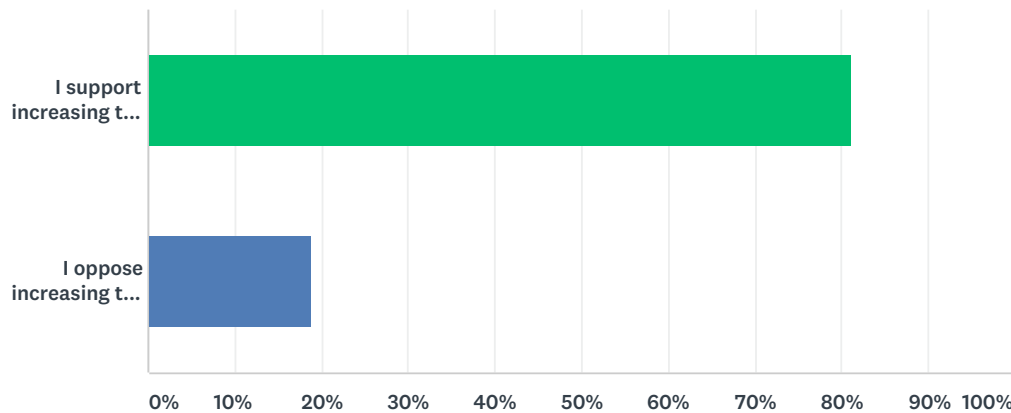

Q2 Under existing Illinois law, the minimum age to buy or possess tobacco products and e-cigarettes is 18 years of age. Illinois municipalities have the authority to raise the minimum age to purchase tobacco within their corporate limits. Lake County became the first county in Illinois to raise the minimum purchase age to 21 effective January 1, 2018. Deer Park, Mundelein, Barrington, Buffalo Grove, and Vernon Hills are among the eleven Lake County municipalities who have also increased the minimum age to purchase tobacco to 21. Do you think the Village of Lake Zurich should increase the minimum age to buy or possess tobacco products or e-cigarettes to 21 years of age?

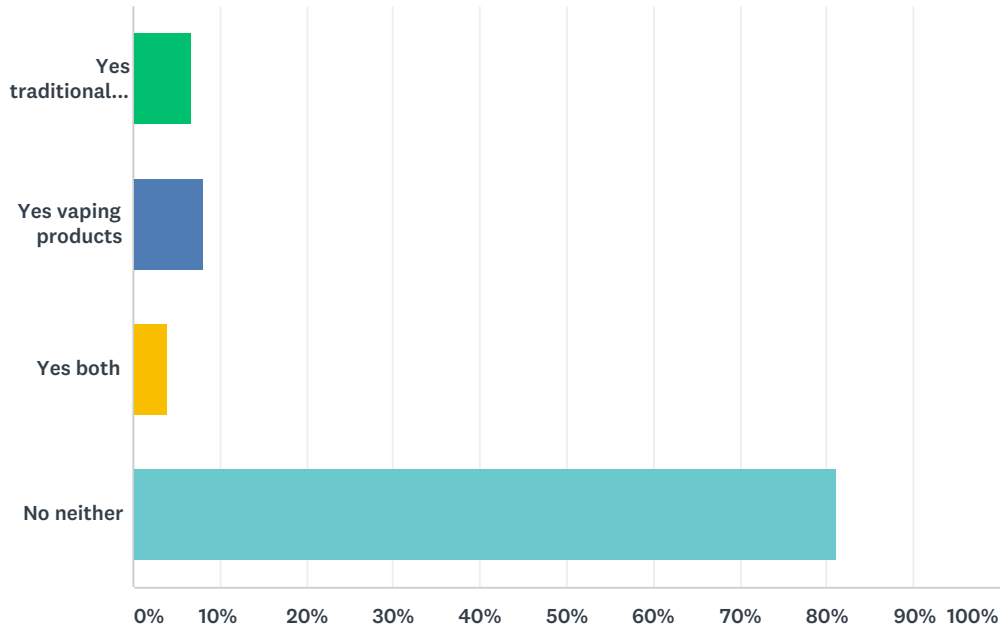
